Matters arising from minutes of previous AGM	<ul> <li>GLL have agreed that the club can use the Trackside bar on several agreed dates throughout the year</li> <li>The club's recognition of Barbara and Derrick Kime's contribution is consistent with that of others</li> <li>The club has paid a higher subsidy to support club members in the NICKO event</li> <li>Improvements to exterior lighting have been agreed in principle by GLL, waiting for it to be actioned</li> </ul>
4.	Chairman's report	Previously circulated to all members. Jeff Green reported that the heat of the Humble Cup was successfully held at the club recently. In response to a question from Paul Littlewood about the parking charges paid by the bridge club, Jeff Green explained that the club negotiated with GLL the package to ensure that individuals do not have to pay for parking.
5.	Deputy Chair's yearly review	Previously circulated to all members.
6.	Treasurer's report and approval of accounts	The report was distributed at the meeting. John Eyre reported that club had £4 000 less at the end of the financial year due to several factors:  • Monthly car parking costs payable to GLL  • Free tea, coffee, water and biscuits at every session  • Cost of cleaning the clubroom  • Painting and decorating the clubroom  • Purchase of dealing machine, tablets and new router  The tuition programme has a surplus of over £4 000.  It is not sustainable for the club to operate at a loss and therefore from  January 01 2019, the cost of playing at a session will rise to £3 per member.  This price rise has already been implemented for the pairs league.  John Eyre thanked Mark Westerly for his help with banking the table money and Arni Anidjar-Romain for auditing the accounts.  In response to question from John Collins about paying table money in alternative ways, John Eyre said that it was being considered.  In response to a question from Bill Thurl about increasing table money immediately, John Eyre said that it had been agreed by committee that it would be increased in January 2019. Bill Gordon commented that apart from

	the increase needed by the EBU's 'Pay to Play' scheme, there has not been an increase in table money for a very long time.  In response to a question from Ronnie Bourne about the large balance in the club finances, Jeff Green said that there was an historic issue of the long-term viability of staying at Gosling.  In response to a question from Paul Littlewood about spending club money on upgrading toilets, Jeff Green described discussions with GLL about upgrading the toilets and the problems that have been encountered.  In response to a question from Mike Sint about the amortisation of cost of capital items in the club accounts, John Eyre answered that the auditor was happy with the way it had been done.  In response to a question from David Wren about the car parking costs, Jeff Green confirmed that the club's payments were based on the number of members not the number of number plates in the data base.
