Kantar bonus tips. 53) When dummy is expected to have a long strong suit at a suit contract and there are two unbid suits, lead from the stronger. However...if one of the suits is headed by the ace, lead from the other. If the two unbid suits look like: K-J-x-x and K-x-x-x, lead from the K-J-x-x suit. If the two suits look like A-J-x-x and Q-x-x lead from the Q-x-x suit. 54) If you can see that there are no possible defensive tricks coming in the side suits, give declarer a ruff and slough. This often promotes a defensive trump trick.

Everett Ness suffered a heart attack January 4-5. He's back at home as of now-hope to see you down at the club real soon!!

There is a misconception that a break in tempo-a 'hesitation'-is a bar to the partner's continued participation in the auction. Law 73: "... inadvertently to vary the tempo or manner in which a call or play is made does not in itself constitute a violation of propriety, but inferences from such variation may appropriately be drawn only by an opponent, and only at his own risk." Inexperienced players get some slack here because it takes some time to process the information in a complex, competitive auction or defense. However, the partner of a hesitator does have a heavier burden of proof that he does have his bid if he carries on. Call the director and that's essentially what he will tell the table...."and call me back after the play if you feel you've been damaged." Now the hesitator's partner may indeed have his bid with or without the break in tempo-but if he doesn't...don't think just because they made their contract that you weren't injured. Call the director back and ask-can they get there without the help of the tempo break? Has the partner met the higher threshold to make his subsequent bid? If the call was marginal-you are due relief-if not, well, nothing lost. No call back-no ruling. On a related note: If a level of bidding is skipped, you should tell opponents "Skip bid please wait" (use the stop card if you have one). After this notice, opponent has not only the duty but the right to pause in the auction. Even if opponent skips the auction without using the skip bid warning or the stop card, you have the right (and obligation) to pause and consider your options. If you skip, don't call the director and tell him "I didn't use the stop card or warning after the (inverted minor raise, jump overcall, etc) but he hesitated anyway and we've been injured." He will (probably) have the good manners not to laugh at you. But you will not be getting a ruling in your favor. Likewise-do take a pause over the skip bid by your opponents (warned or not) lest you be guilty of conveying information to your partner by a quick pass and causing an injury to your opponents. Directors get called on that one too.
