More About Revokes

If you realized you have revoked, it is unethical to take any action to try to hide the fact that you revoked. Revoking again to hide the fact that you revoked the first time or closing up your hand and not giving the opponent an opportunity to see what is left in your hand are examples of unethical behavior.

There is no such thing as a revoke penalty. There is no penalty for revoking. The proper term is "trick adjustment," usually a one or two trick transfer to the other side depending on whether or not the revoking person won the revoke trick.

Contrary to popular belief, dummy can revoke (sometimes because on card is hidden behind another or one card from dummy has fallen unseen on the floor). However, if dummy does revoke, there is no trick adjustment.

If you realize you have revoked before you or your partner has played to the next trick, the revoke can be corrected. In such a case call the director BEFORE you take any action. Let him supervise the correction of the revoke.

The term "established revoke" means that the person who revoked or her partner has already played to the next trick. If a revoke is established, it cannot be corrected.

A revoke that occurs on the next to the last trick (trick 12) has to be corrected regardless of whether or not you have already played to the last trick. Call the director when a revoke happens on the next to the last trick. He is the one who knows the exact procedure in correcting the revoke.

It does not matter what would have happened had you not revoked. Recently, at the Club, declarer revoked when she trumped the opening lead. She had the Ace of the suit led and, if she had not revoked, she would have won the trick anyway, but that does not make any difference. There is still going to be a two-trick transfer at the end of play.

The term "rectification" is used to describe the transfer of tricks due to a

revoke. Only the direction can authorize a rectification.

Sometimes a revoke will mean that the opponents gain a trick because you revoked. Sometimes the trick transfer will result in the opponents getting back a trick that they would have won anyway.

Do not EVER turn over cards that have already been played to check on a revoke until the director arrives and tells you to turn them over. That can lead to getting the cards out of sequence and it makes it harder and more time consuming for the director to reconstruct what happened and authorize a possible rectification.

Do not get angry with an opponent when she catches you in a revoke or with the director for enforcing the proper bridge laws. Revokes are a part of the game. So is owning up to them and accepting the consequences.

Services that PALSS provides includes:

- Affordable medical treatment for individuals (free up to \$15)

- A men's clinic
- A women's clinic
- A Food Pantry for individuals in need
