  - b. YTD net operating gain \$13,800.
  - c. Checking account balance \$9,454.
  - d. Schwab account balance \$51,434.
  - e. The club accepted a \$1,000 donation from a donor who wants to remain anonymous.
- 3. <u>Manager's report</u>: Club manager Emilio Lopez reported:
  - a. 411 tables played in July 2022. 266 face-to-face; 145 BBO.
  - b. 323 paid members YTD 2022; October 2023 membership drive looming.
  - c. New playing cars and boards are needed; \$700 \$800 cost anticipated.
  - d. New vacuum purchased \$190.
