- c. Rick Shapiro was appointed to replace David Doretsky on the Board. Thank you to Rick for stepping up.

3. FTLBC Annual Board Elections Results

- a. Election Committee Report attached. Election results ratified by Board.
- b. Knyvett Lee and David Doretsky were elected to FTLBC Board.
- 4. Treasurer's report: Treasurer Deborah Branch was absent.

5. <u>Club Manager Emilio Lopez's report</u>:

- a. October table count 346.
- b. Game directors Gilbert Stockton and Robin Kupperman reported underpayments due and owing.
- c. An additional row of tables was added to large game room.
- d. Scrabble and Mahjong tournaments are scheduled for January 2023 at FTLBC.
- e. "House" committee chair Al Kimbrough indicated his intent **not** to attend board meetings and to send his report through the report of the club manager.

6. Education:

- a. Chair Robin Kupperman reported that the ACBL "Project Boost" program generated 113 leads for bridge classes. Robin made over 70 calls which resulted in 4 students enrolling to date.
- b. Board member Mark Yeager suggested that the "Easy Bridge" program may be worth investigating.
