#### Tacos and Teams:

A motion was made by Mike Siebenhaar to change the format of Tacos and Teams to Open, Stratified, as of June 2023. Craig Hemphill seconded. The motion carried unanimously.

## **Parking Lot Lighting:**

Mike Siebenhaar met with representatives of the Church of Eleven22 regarding lighting in the parking lot. They proposed removing the present generator and replacing it with a solar powered light pole to be placed at the end of the concrete. This pole will not interfere with parking. Nancy Whitmire made a motion to accept their proposal. Mike Franzoni seconded the motion. The motion carried unanimously.

# **Painting of Building:**
