- 4. **Board Member to replace Linda:** Julie moved that Trella Bromley replace Linda Drake on the Board. Michele seconded. Motion carried unanimously.
- Linda Drake's report: Nancy Stein and the game directors have been very supportive. Masterpoint reporting to ACBL for April, 2014 was late due to lack of knowledge as to how to send. However, report has now been sent and accepted by ACBL.

Quick Books has the 2015 updated version available now at accost of \$299.00. As of May 31, 2014 there will be no on line support for the 2011 version that the JSOB is currently using. Linda feels we do not need to purchase this update at this pint in time as it will not affect her bookkeeping. However, she will need to do so in November. At that time she will ask the board for the \$249 needed to update the then outdated version
