#### MINUTES OF THE ANNUAL GENERAL MEETING AND PRESENTATIONS

Wednesday 7th June 2017 at 7.15 p.m.

- 1. Apologies for absence: were received from Val Ruddock, Steve Foster, Pauline Dignan, Bharat Thakrar, Jenny Grant, Garry Whiteman, Sobhag Shah, Charu Shah, Alan Lord, Linda Lord, Althea Bandy, Mary Johnson, Audrey Mount, Gary Jones, Mike Ayers, Stephen Barney, Lyn Hilton, Mike Gould, Tom Lindop, Duncan Jones, Sheila Stockdale and Kerri Happer.
- 2. Minutes of the 2016 AGM: Tim Glover, seconded by Simon Stokes, proposed that these minutes be accepted. The proposal was unanimously agreed and the minutes were signed accordingly by the chairman Dean Benton.
- 3. Matters arising from the above which are not on this agenda: none received prior to the meeting.
- 4. Report of the Committee for the year 2016-2017: Dean thanked those present for attending the AGM. He was pleased to welcome back Market Harborough BC who recently re-joined the EBU. A small increase in membership was reported. Dean was pleased to report the continued support for the LCBA tournaments. The tournament directors were thanked for their handling of the events. Steve Wright was thanked for his help in enabling the Bridgemates to be used in suitable events. Those achieving success in the National Swiss teams were congratulated. Junior member Ben Norton was singled out for his impressive five wins at National level. Pat and Neil Beasley were thanked for ensuring that the LCBA trophies were prepared for presentation at the meeting. Following the 2015 meeting with all local bridge clubs, 7 clubs have taken the opportunity to purchase sets of Bridgemates sharing over £2000 discount. Steve Wright was again thanked for demonstrating how the Bridgemates work to these clubs. Dean further reported that the LCBA League, with the help of the LMS, is functioning well. Brian Stockdale was thanked for his work as League secretary over the last two years. His successor, John Wilcox, was welcomed back to the committee. Fixture secretary Dick Pathan was thanked for again organising the Midlands League teams during the season albeit it proved not to be their most successful season. The LCBA committee propose that for the 2017/18 season onwards, all EBU registered LCBA clubs will be asked to nominate a representative who may attend LCBA committee meetings and will be routinely sent agendas for and minutes of the meetings. This proposal reinstates the system in operation when the LCBA was founded. Sadly, 11 deaths have been reported to the committee during the season. Dean concluded by thanking everyone for the honour of his being LCBA chairman for the past two years and presenting General and Membership secretary Pat Beasley with a bouquet as his personal thank you for her help. Richard Smith, seconded by Henry Cooklin, proposed that the committee report be accepted. The proposal was unanimously adopted.
- 5. Presentation by the Treasurer of the Statement of Accounts for the year 2016-2017 duly certified by an independent Financial Examiner: Henry Cooklin announced that the coming season will be his last as LCBA treasurer. Richard Rees has kindly volunteered to take on the role for the 2018/19 season. Henry reported that the LCBA have made a loss of £871 for the season largely due to the depreciation factor built in for the purchase of the LCBA Bridgemates and the purchase of new playing cards. Brian Stockdale, seconded by Ben Norton, proposed that the accounts be adopted which was unanimously accepted.

# 6. Proposals from the outgoing Association Executive Committee:

- a) That for 2018-2019, members playing at LCBA affiliated clubs, the LCBA P2P component remains at 8p
- b) That for 2018-2019, EBU direct members and others not active in P2P sessions at LCBA affiliated clubs, the LCBA Membership subscription remains at £4.00 and £1.50 for junior members
- c) That Irene Krantz be elected a Life Member of the Association
