8. Old Business

- a. **Seniors Community Grant Application**: Danielle called Katy Hunter regarding the Grant and asked her to contact our MPP Vic Fedeli. Katy sent an email to Vic Fedeli's office and received a response from his assistant that they would look into why we have yet to receive any type of response from the government. On Tuesday, October 25, Katy informed Danielle that the government now claims that they never received our request for the grant.

Our games are one of the lowest paying in many communities. There has not been an increase in about 5 or 6 years.
- e. **District Grant**: Paul will send an email to the district asking for assistance and why we need a grant to keep the club open.
