PASS OUT OF ROTATION

Calls (bids) are made in a clockwise rotation starting with the dealer of the hand (Law 28). If a player makes a call when it is not their turn the call is said to be out of rotation. Offender's right hand opponent may elect to accept the call out of rotation and if accepted the auction continues without rectification (Law 29 A). If the call out of rotation is not accepted the auction reverts back to the player whose turn it was to call but the offender is subject to certain restrictions in future calls. These restrictions are different if the illegitimate call was a pass (law 30), a bid (Law 31), or a double or redouble (Law 32). This article will deal with a pass out of rotation. Future articles will deal with the other two violations.

If the Pass out of rotation was committed before any player has bid the offender must pass when it is their next time to bid (Law 30 A)

If the violation occurs after any player has bid (Law 30 B):

- 1. If it was offender's RHO"s turn to bid the offender must pass when it is their turn to bid (Law 30 B 1.).
- 2. If it was offender's partner's turn to bid the offender must (Law 30 B2a) pass whenever it is his turn to bid and (b) (Law 30 B2b) offender's partner may make any sufficient bid or pass but he cannot double or redouble.
- 3. If it was LHO's turn to bid the call is treated as a change of call and Law 25 applies. Law 25 states that the offender's RHO may 1. accept the substituted call and the auction would continue or 2. not accept the substituted cal in which case the original call stands and the auction continues. In either case Law 16D would also apply which means there has been unauthorized information conveyed by the bid of rotation and offender's partner cannot take advantage of this unauthorized information.

Judy Flickinger, Bridge Player and Author

Judy Flickinger is an active duplicate bridge player, often seen playing in 299er games in The Villages with her husband Roger. Judy has been playing bridge for 40 years, but Roger Flickinger came to the game reluctantly. Now he is addicted, and is Judy's favorite partner.

Judy is also known in The Villages as an author and public speaker. Her book *Spirit Matters* was published two years ago and sums up her philosophy after decades as a nurse, and working in hospice since 1989. The full title provides a good summary of the goal of the book: *Spirit Matters: How to Remain Fully Alive with a Life-Limiting Illness.* As a result of her book and her work in hospice, Judy received the Central Florida "Woman of the Year" award in 2011.

Judy's book draws heavily on her own experience, not only her professional experience but a bleak period in her own life when she was suffering a kind of emotional death. She defines "spirit" as "who I am as a person. It is not who I am as a body or my physical appearance, but who I am inside. It is what gives life to my physical body." Although death is inevitable, it is essential to keep the spirit, the real person inside the body, alive and nourished during a life-limiting illness.

Spirit Matters relates the personal stories of many of Judy's patients, and the successes several of them achieved for themselves or their dying loved ones by focusing on what really matters. Occasionally the success stories result from ignoring the traditional medical approach of prolonging the life of a person suffering in pain with no hope of recovery. I read Spirit Matters shortly before my mother suffered a serious fall at age 95. In the hospital emergency room a neurologist assured me that my mother's jaw would be wired shut and after three months or so of forced feeding she might recover enough to be aware of her surroundings. The next day my family arranged hospice care for my mother, and she died peacefully and without pain not long after. Judy's book discusses the type of misguided care so often given to people near the end of their lives.

Finally, it's important to emphasize that while reading a book about end-of-life care is not something that most of us look forward to doing, Judy's book is not a gloomy one, but rather full of insights and inspirational stories about how you can nourish your own spirit and the spirits of loved ones with life-limiting illnesses. As Judy puts it in the book, "you may not have much control over the progression of your disease, but with a healthy spirit, you can have greater control over your life."

Zero to Sixty in....... By Jon Williams

Like a fast car, the club's Mentor Program really took off. Within two months after the Board approved it at the December meeting, there were over 60 mentors and novices working to improve the latter's bridge skills.

Currently, there are 32 mentors assisting 35 novices. Particularly pleasing has been the participation of our "snowbirds", both as mentors and novices. Most of the mentor-novice pairs were formed by being matched up based on their applications, but several were acquaintances who decided to work together once they saw how the program was working.

Mentors are asked to play with their novices at least twice a month and to spend some time before and after each session on ways to improve. Most are going over and above that, playing in open games several times a month.

To supplement open play, the club dedicated one of the Sunday games each month as a special Mentor-Novice Pair game, open only to participants in the program. The first of those, in February, featured 11 tables; the second, in March, had 12 tables. The director sets up a slightly abbreviated movement (22 boards the first game and 24 the second) to allow time for discussion during each round. A noteworthy aspect of these special games is the relaxed atmosphere, with the primary emphasis on improving skills rather than competition.

Winners in the February game were Buck Buchanan - Dottie LaBrie N/S and Sally Gauthier - Gwen Wright E/W. Second place went to Dave Stentz -BJ Chiota N/S and Ruth Srulevitch - Margaret Sarno E/W. Buck and Dottie were first overall with 65%.

In the March game, Bess Bailey - Cathy Thomas placed first N/S; Kay Jones - Pat DeArmond were first E/W. Second place went to Jack Gleckner - Gene Rodriguez N/S and Sally Gauthier - Gwen Wright E/W. Bess and Cathy had a 66.48% game for first overall.
