Here I am in Bogota where they are having a downpour this morning but it just means going to the store to get a big umbrella.

I feel really rich here; went to the ATM and got 500,000 Columbian Pesos for \$277. Got 5.....100,000 peso notes...LOL. The years of political unrest here have taken its toll on the money.

Flying over the country is getting to watch a spectacularly beautiful country. Today even in the rain I am going to Montserratt which is the highest point overlooking Bogota and where one of the big Catholic churches is located.

I have to be real careful to take things slowly here since the altitude is 7200 feet and if I go very fast I get very dizzy. The locals say it is from not getting enough oxygen to the brain.

I have one for medicare and our insurance. Evidently my Flomax pills in my luggage were interesting to someone else because I arrived without them. They are not prescription down here so I went to the Pharmacia to get some more and 30 pills cost \$65.....LOL. I like the \$5 version at Walgreens better with the drug insurance.

Bogota is a huge city....8 million...in a country of 40 million. Lots of cars....the taxis are little 4 seater 4 cylinder Hyundais but surprisingly roomy on the inside. And it costs about \$3 to go wherever you want in the immediate vicinity. I give them a 20,000 peso note and I get 15,000 back. What a hoot! The peso is at 1840 to one dollar.

That's the late news from here thus far......

### 299er News (Club Members with Fewer than 300 Masterpoints)

Pat Holmes was listed in the April ACBL Bridge Bulletin as one of the top 25 in the Ace of Clubs contest, for those who started 2012 with 5-20 masterpoints. Pat earned 59 masterpoints in 2012 to make the top 25 nationally.

Dave Michaelson, who graduated from the 299ers when he hit 300 masterpoints about six months ago, got the final silver points he needed in Ocala, and is now a Life Master.

### **Ocala Tournament**

In the ACBL Sectional Tournament in Ocala in April, a record number of Villages 299ers participated, and 42 of them won masterpoints. This overview does not list all of them, and is also limited to those 299ers who played with other Villages 299ers.

Mary Van Steelandt and Sally Jepsen were the big winners, earning 8.84 and 7.97 masterpoints respectively. They played together in 299er pairs in two games (over 61% in each), and Mary played with Evelyn Bennett for an overall first of almost 68% in another 299er pairs event. Mary and Sally teamed with Sandy Baker and Sandy Goodwin for first place in the "C" stratum of Swiss Teams.

Other first place pairs were Maryann de Roche and Bob Tolpa, whose 65% game was first overall in one of the 299er pairs events; Carlyn Bryan and Carol Richardson, who twice finished first in their stratum in 299er events; Marilyn Hubbard and Nancy Speedy, whose 60% game earned them a first in "B" in a 299er pairs event; and Sandy Baker and Sandy Goodwin, who finished first overall with a 61% game in the final 299er pairs event. Janet Dunn and John Dunn finished first in "B" in that event.

Among those at Ocala attending their first tournament, Betty Einstman and Pat DeArmond finished first in the "C" category in their 299er pairs game. Maggie Finch (who entered with 7 masterpoints), B J Chiota, and Carol Payette were among the other 299ers playing in their first tournament who had good games and earned masterpoints.

### St. Petersburg Special Sectional April 28 – NLM Swiss Teams

Mike Peleck, Janet Gawenda, Pat Holmes, and Colleen Clark played in a special sectional for Non-Life Masters in St. Petersburg in April, and finished first not only in their "C" stratum but also in "B", earning 2.93 MP each.

The Board has chartered a committee to develop an education program for the club that will cover the diverse interests, levels of experience, and learning styles of members and prospective members of the club. The educational opportunities will offer a range of formats, from short workshops to multisession discussions while operating within the guidelines that the Villages Recreation Department sets for club activities. Heather Shane chairs the committee. The committee members are: Buck Buchanan, George Clark, Julie Clark, and Dean Robinson. We expect that the educational program will mesh very well with the Mentor/Novice program that provides reinforcing experiences in live play. Expect to hear more about their plans in the coming months.

Looking forward, the Board investigate way to reinvigorate the Sunday Swiss team games. The Eight is Enough format for the games has continued to be a success, but attendance in the open games has fallen, especially in the off-season.

During later June and July we will make a concerted effort to update the email addresses in the club data base. When you have a moment, please check your email address on the directory. # THE DIRECTOR'S CORNER Paul Matheson

Rule 16 deals with a player's responsibility for dealing with unauthorized information. Most of us are familiar with the rule as it applies to unauthorized information conveyed by our partner but the rule (Section C) also deals with unauthorized information received from other source. Specifically information "accidentally" received "by overhearing calls, results or <a href="remarks" (italics added) of others.">remarks</a> "(italics added) of others. The directors have repeatedly asked that players not discuss hands or results with others during the game for a good reason. Not only is it disruptive to others but it may also lead to others obtaining unauthorized information which would put them in an ethical dilemma. The rules state that a player obtaining this information should immediately notify the director for some form of rectification. Possible rectifications would be changing the players position so the player with the unauthorized information plays the hand containing the information; redealing the hands if possible; allow the play to continue but allowing the director to make an adjusted score if necessary; or award an artificial adjusted score. So once again please refrain from discussing hands or results during the game.

Rule 31 deals with a bid out of rotation. There are different remedies based on which player was supposed to bid.

If it was RHO's turn to bid, RHO would then make a bid. If RHO then passes the offender must make the same bid and play continues in the normal manner. However if RHO makes a bid other then pass, the offender can make a sufficient bid in the same suit there is no further rectification. However if the offender makes a bid other then in the same suit his partner is barred from any further bidding. There also may be lead restrictions.

If it was the offender's partner or their LHO's turn to bid and LHO had not previously bid, then offender's partner is barred from bidding for the rest of the auction.

Rule 32 deals with a double or redouble out of rotation. An admissible double or redouble may be accepted by the opponent next in the rotation and normal bidding would continue. If the double or redouble is not accepted it is canceled and

- a. If it was partner's turn to bid the offender must pass for the rest of the auction. Lead restriction may apply.
- b. If it was RHO's turn to bid and RHO passes the offender must repeat the double or redouble and bidding continues. If RHO takes a legal bid the offender can make any legal call but their partner must pass for the rest of the auction. The director retains the right to make an adjusted score if they feel the offending side gained an advantage from the irregular bid.

What happens when a partner doubles his partner's bid or redoubles his partner's double? If offender's LHO bids before rectification the double or redouble and all subsequent calls are canceled and the auction proceeds as if there was no irregularity. If LHO does not call before rectification the double or redouble is canceled and offender must make a legal call. Their partner must pass for the rest of the auction. Lead restrictions and the director retains the right to make an adjusted score if they feel the offending side gained an advantage from the irregular bid.

### The Common Game

At the recent Ocala Sectional I got talking to a lady from another club in Florida and she told me all about this web site.

She said that like us, they went over to 'dealt hands' about a year ago and met with a lot of resistance..... Comments like "finesses never work" and "I always get dealt a bad hand" etc etc. were common. She said that after a while, only the "diehards" were against and nearly everyone, certainly all those who admit that they have still much to learn, thought the hand records available to analysis far out weighed any doubts they still had. After all, we all get dealt the same hands and duplicate is all about trying to beat the rest of the room. Otherwise we would all still be playing Kitchen Bridge....

I digress. She told me about 'The Common Game', a web site where they produce the hands available to be played by any club who wishes to join in and after each game both the bridgemate files and the results are uploaded onto their site and then one can go to the site and see all sorts of very useful information and statistics.

I took it to the board, they agreed that it was worth participating. They were most impressed that the total cost to us was only \$0.00:)

The only small downside is that the directors now have 2 files to email to Paul and myself and I have to spend more time at the computer..... BUT the upside, after just 3 days of results, is looking incredible.

I get an automatic email telling me that the game I participated in is now online. When you go to the site, the first page you see is the home page giving you options to look at the latest game or to go back into archived games, all 299er's have their own games. There are fun things like the leader boards and very interesting Postmortem analysis. If you click on the latest game, it gives the top 20 pairs for North/South and East/West, not only within The Villages, but across all of the clubs who played those hands.

Looking at Thursday 16<sup>th</sup> of May, out of 389 pairs, our own Joe and Don came in first, Gladys and Jon 4<sup>th</sup> and George and Mary 20<sup>th</sup> WOW!! You can click on anyone's name and see what they did on each hand and then if you click on the board number you see the hand record and what everyone else bid. Very interesting.

After only 3 days, there is still a learning curve for the director's so please be patient with them. Also, the games at Seabreeze, at the moment do not have Bridgemates, so the information is not complete..... as yet. But we will get there.....

## Villager Expelled from 299er Games

After more than eight years as a 299er, David Haskell finally reached 300 masterpoints in April and is no longer permitted to attend the 299er games. Searching for someone to blame for this misfortune, which will force him to play with the sharks, David singled out his partners.

"I would still be a 299er if it weren't for my partners, whom I blame for my graduation. Had they not played so well and recovered so nicely from some of my bizarre bids, I could still play in 299er games for another year or two," David said. Along the way, he has seen some of his partners surpass 300 points and move on to open games – especially Marilyn Graham, whom he met in a non-sanctioned game at Chatham Recreation Center 9 or 10 years ago. They have been bridge partners for six or seven months a year ever since, and according to David, "Marilyn remains the only partner who either understands some of my more unpredictable bids, or who has been learned to hide her astonishment."

Together, David and Marilyn won two trophies (valued, he says, at about 35 cents each) for finishing first in 299er sessions at the North American Bridge Championships in Orlando in 2010. In retrospect, David now wishes that he had played in more open sessions in tournaments where he might have earned more gold and silver points, and he needs "lots of both colors" to become a Life Master. But at his present rate, David expects to reach Life Master "well before 2025."

David Haskell provided the impetus for the first 299er game in The Villages by submitting a petition to the Board of Directors in 2008 for a separate 299er game or section. The proposal was adopted and the Monday afternoon 299er game was born.

Drawing on his background as an English teacher and lawyer, a few years ago David began writing an occasional column emailed to 299ers in which he would analyze a particular hand played in the Monday 299er game. Hand records were not available when the email newsletter started, and David would write down the hands of interesting boards after Monday games. Then came photographs of the hands; and with hand records now available, his job has become easier. He emphasizes that he is not an expert, and sends his emails only to those with fewer than 300 masterpoints who sign up for it (currently about 140 players). The typical weekly email focuses on one hand played on Monday, summarizes the results, and provides what he characterizes as a non-expert discussion of bidding and play alternatives. Email recipients who disagree with David's analysis have not been reluctant to set him straight, and he has been known to issue updates and corrections. He is looking for a volunteer to continue his emails to 299ers.
