Mistaken Explanation or Mistaken Call?

Rule 40 states that both partners must have identically completed convention cards which describe their systems. Implied within the rule is the fact that both partners must be familiar with their agreements. Players may refer to the opponent's convention cards 1. prior to the start of the auction; 2. during the clarification period and 3. during the play when it is their turn to play. They are not allowed to look at their own cards after the auction starts until the play is over.

Opponents are entitled to be fully informed of a pair's partnership understandings. A partnership is not allowed to have any private agreements. Opponents are entitled to a full explanation of a partnership's methods and agreements.

One of the most misunderstood situations occurs when a player receives incorrect information of the opponent's agreements. Usually the question is whether the explanation was an incorrect description of the agreement or was the call in mistake. There is a big difference.

A mistaken explanation is when a player provides an incorrect description of the partnership agreement. For instance suppose the partnership agreement is they are playing Cappeletti over an opponent's 1 no trump opening. North opens 1 no trump, South responds 2 diamonds which shows both majors in their system however North explains the bid as being natural. This is an incorrect explanation of the agreement and if East - West are harmed by this misinformation the director can adjust their score. It should be noted that South has become aware of the mistaken explanation which is unauthorized information. He must not base additional actions based on this information. For instance if South now bids 2 no trump South must now bid based on their agreement of what that bid means after his 2 diamond response. If their agreement is that 2 no trump is to play South must pass.

If there was misinformation supplied during the auction and the offenders are declaring, the opponents must be apprised of the misinformation prior to the opening lead. If the offenders are on defense the hand must be played and then the offenders tell the declarer of the misinformation. The director should be called in all cases of suspected misinformation.

However if South forgot about the agreement and bid 2 diamonds thinking it was a transfer instead of showing both majors this is a Mistaken Call. In this case East-West are not entitled to relief regardless of the result because they were correctly informed of the opponent's agreement. The opponents and opener all will base their calls on the same information. Again South is the recipient of unauthorized information when North explains the true meaning of the 2 diamond bid and again he cannot use this misinformation to base a subsequent call. Thus if North now bids 2 spades South cannot make another bid based on the unauthorized information.

How does the director decide if an adjusted score is warranted after misinformation was conveyed? There is a multi-step process used in all cases of unauthorized information:

- 1. Was there unauthorized information? If yes proceed
- 2. Were the opponents damaged? If yes proceed
- 3. Were there logical alternatives to the offender's call? Would a significant minority of players of the same class as the offender make a different call?
- 4. Did the unauthorized information suggest the call chosen over alternatives? If yes
- 5. Adjust score.

The simplest way if you don't want to bother with anything else is to send an email to :- fastresultshelpdesk@gmail.com and in the subject line enter your ACBL number. They will do the rest.

If you want to find out a few more things...

- 1. Using your web browser type in thecommongame.com
- 2. On the left hand side there are 2 icons, one with a moon and stars and one without. This is for the afternoon and evening games.
- 3. Below there are links for you to look at the latest games both open and 299er and to go back and search for a specific game. If you click on one of those it will give you the top scores for that game in the country and you can also click on a name (same as our web site) and it will give you their scores and how they did on each hand. You might even find your own name ©
- 4. Scroll down and it will give you the leaderboards, (hard for us as we only get 80% of the available master points.)
- 5. Back to the top and on the right hand side there are 3 orange icons, "tutorials_. FAQ's and "Contact us" All are very useful, and if you need to contact them, they are great people and all have become very good friends.
- 6. OK, now below that, you can type in your ACBL # and then log in.
- 7. This will give you your personal results and where you played. It will show you your field rank, your results according to your handicap and much, much more.
- 8. On the right hand side in orange is an icon "modify Profile" This is where you fill in your details. Under notifications, if you click "email", whenever you play, as soon as the director has uploaded the game, you will get an email. Also if you do the same for Fast Results, the same thing will happen if you play in a tournament. You can also enter your BBO user name and what systems you play.
- 9. Another very useful tool is if you go back to the home page and click on the game you have just played in. keep scrolling down and all the boards are there and in about 8 to 10 hands, experts have given their analysis on the bidding or play of the hand which can be very informative.

VILLAGES 299ERS SCORE WELL IN DAYTONA

Six 299ers earned more than 10 masterpoints each at the recent Daytona Beach Regional tournament, and a total of 14 earned at least five master points. Because of space limitations, this column focuses on top point winners of 299ers who played with other 299ers from The Villages.

The most outstanding accomplishment was the one-day performance of Pat Holmes and Mike Peleck in the Gold Pairs. They not only won both sessions easily, but they averaged over 71% for the double session, ending with a 75% game. That performance was worth more than 9 gold points. When asked about the secret of his success, Mike graciously said, "A good partner." In addition, both Pat and Mike earned points in

other events with Villagers. Pat has accumulated so many masterpoints lately that she will soon be banished from the 299ers.

The team of Margaret Sarno, Gwen Wright, Sharon Amberg and Emiel Domis earned almost 12 masterpoints for winning a knockout. Half of the MPs awarded for this win were gold. All four earned additional points in other events. Emiel had surpassed 300 points just before the tournament, so he was technically not a 299er. He now needs only 0.1 gold for Life Master.

Judy Flickinger and Brenda Pollak played as a team, and scored well in several 299er pairs events, earning almost 7 masterpoints each. Their best effort was a 67% game, easily winning, and they finished second (first in their stratum) in another.

Other 299ers who won more than five masterpoints were B.J. Chiota and Bob Vicars, who scored more than 6 MPs paired in several events; and the knockout team of Bob and Ruth Ann Pethtel and Janet and John Dunn, who won almost 5 MPs in a knockout and some points in other events as well. In short, Villages 299ers performed very well at Daytona, with almost 30 winning masterpoints.

Roman Keycard Blackwood 1430

Eddie Kantar (2008) in his book "Roman Keycard Blackwood – The Final Word" 5th Edition, published by Master Point Press recommends that 1430 be used if the strong hand asks and that 0314 Roman Keycard Blackwood (RKCB), often just called Roman Keycard (RKC) as on the Convention Card, be used if the weak hand asks. If you do not follow his guideline and have to choose one, it is best to use RKCB 1430 since more often than not the strong hand is asking. The conventional bids for RKCB 1430 follow.

4NT when Hearts or Spades are the agreed upon suit (Keycard Ask)

5 - 1 or 4 Key Cards

 $5 \Rightarrow = 0$ or 3 Key Cards

5♥ = 2 or 5 Key Cards without the Queen of Trump

5♠= 2 or 5 Key Cards with the Queen of Trump or holding a 6th Trump

Kickback/Redwood (Neil Timm offers another convention--editor.)

Use 4 of the suit above the agreed upon suit: diamonds for clubs, hearts for diamonds, spades for hearts and notrump for spades. While the term kickback always applies to all suits, some reserve the term Redwood only for the minors.

Voids (NEVER show a void with Zero Keycards, ignore the Void)

5NT = 2 or 4 an even number of Key Cards with a void

6 of suit below the trump suit = odd number key cards (1/3) in the suit below the trump suit

6 trump suit = odd number of key cards (1/3) with a void in higher ranking suit

Note that 4NT is used ONLY if the AGREED suits are the MAJORS, NOT for the Minors. For the minors one uses 1430 Minorwood (where 4♦ and 4♣ are used for diamonds and clubs, respectively)/Redwood. Furthermore with no agreed major, some recommend that the last bid suit be used for RCKB 1430. This approach only works if the partnership has a fit for the last bid suit. When this is not the case, it usually does not work since

one cannot tell the difference between holding the ace or the king in the last bid suit. With no agreed upon suit Kantar recommends that 4NT be used for Blackwood where only aces count.

DOPI/ROPI Interference at the 5 level **DBL/RE-DBL**: 0 or 3 Key Cards and **PASS**: 1 or 4 Keycards

DEPO Interference at the 6 level **DBL**: Even # Key Cards (0/2/4) or **PASS**: Odd # (1/3)

QUEEN ASK:

After 5♣, **5**♦s is Queen Ask

Denial: Return to the five-level of the agreed upon suit

6 Level of agreed Suit: With Queen and no side-suit king or extra trump

6 Level of Lower King Suit: With Queen and 1/2 side-suit kings **5NT:** With Queen **without** a side-suit king, but trump extra

After 5♦, 5♥ is the Queen Ask – with zero key cards, PASS

Denial: If spades are trump, bid 5♠, with hearts bid 6♥.

6 Level of Lower King Suit: With queen and side king **5NT:** With queen **without** a side-suit king, but trump extra

6NT: With queen **without** a side-suint king and 4-3-3-3 distribution

5NT is a Specific King ASK (NOT NUMBER OF KINGS) (This is an advanced option—editor.)

YES: Bid Lowest King Suit BELOW the agreed upon trump suit

NO: Return to the agreed upon trump suit

To ask for a SECOND king, the asker bids the suit. Without, return to the agreed suit.

Holding a SECOND king: Make a 1st step response, including 6NT with Kxx(x)

Make a 2nd step response with Kxx

Raise the ask suit with Kx

SPECIFIC SUIT ASK (SSA) After $5 \clubsuit$: $5 \blacktriangledown$, $6 \spadesuit$, $6 \spadesuit$ is SSA. After $5 \spadesuit$: $5 \spadesuit$, $6 \spadesuit$, $6 \blacktriangledown$ is SSA

Make a 1st step response, including 6NT with third-round control Qx(x), Ax, AQx, xx

Make a 2^{nd} step response with second-round control Kxx(x)

Make a 3rd step response with Kx

Raise the ask bid with KQx and JUMP to the trump suit with a singleton

While RKCB 1430 is a valuable convention for investigating small/grand slams, it is not the only tool for slam bidding. Other methods include cue bidding; Simple Gerber, Roman Keycard Gerber, exclusion Keycard Blackwood (EKB) sometimes called Voidwood, Minorwood/ Kickback/Redwood sometimes referred to as Bothwood, Double Roman Keycard Blackwood (DRKCB) when the partnership has agreed two suits (Major-Major, Major-Minor, Minor-Minor), ACOL 4NT, Variable Roman Keycard Blackwood, Spiral Scan bids, Baby Blackwood, and many more.
