#### CONTINUATION OF MARTY BERGEN'S 21 RULES OF BEING A GOOD PARTNER:

10. Do not ever criticize or embarrass your partner in front of others.

11. Remember that bridge is only a card game.

12. Have a good time, and make sure that your partner does also. "Bridge is for fun. You should play the game for no other reason. You should not play bridge to make money, to show how smart you are, or show how stupid your partner is.... or to prove any of the several hundred other things bridge players are so often trying to prove." This is a bridge legend by Charles Goren.

13. Trust your partner; do not assume he has made a mistake.

14. Although it may be unfashionable, it really is okay to be pleasant to a partner with whom you also happen to live with. (con't on page 3)

15. Remember: "The worst analysts and the biggest talkers are often one and the same." Bridge columnist Frank Stewart. Think twice before verbally analyzing a hand. Do not embarrass yourself with a hasty, inaccurate comment.

16. When you voluntarily choose to play bridge with someone, it is not fair to get upset when partner does not play any better than usual.

17. Never side with an opponent against your partner. If you cannot support your partner, say nothing.
18. If you think you are too good for a partner, and do not enjoy playing bridge with him/her, do everyone a favor and play with someone else. That is clearly much better than being a martyr. However, be careful before burning bridges—another player's grass may not be.....

19. Learn your partner's style, regardless of how you feel about it. Do not expect your partner to bid exactly as you would. When partner makes a bid, consider what he will have, not what you would have.

20. Try to picture problems from partner's point of view. Seek the bid or play that will make his life easiest.21. Sympathize with partner if he makes a mistake. Let your partner know that you like him/her, and always root for him/her 100%.

# THE DIRECTOR'S CORNER PAUL MATHESON

One of the most vexing problems facing Directors is the claim that a player's action conveyed unauthorized information to their partner. Common challenges arise when a player hesitates for a long period of time before making a call (a so called "break in tempo") or when a player gives the opponents an incorrect explanation of their partnership agreement.

Law 73 and Law 16 cover the rules of partnership communication and unauthorized information. They state in part that a player cannot take advantage of unauthorized information conveyed to him from his partner's "... extraneous remarks or gestures, questions asked or not asked..." A violator's partner "...must carefully avoid taking any advantage..." of this unauthorized information.

Parties who felt there has been a hesitation should immediately inform the director of the break in tempo although one does not forfeit their right to appeal if they wait until the end of the play. If the Director is called at the time of the hesitation they will advise the offender's partner of their legal obligation not to take advantage of the unauthorized information. They can make any call that is clear cut and the auction and play would continue. At the end of the play if the innocent party feels they were harmed by the hesitation they should call the director who would then make a ruling.

Innocent parties are not automatically entitled to relief if there is a violation. There are steps that have to be met for relief to be given. They are:

- 1 Was there a violation? If so
- 2 Was the innocent side damaged? If the answer to 1 & 2 is yes
- 3 Did the offender's partner have any logical alternatives to the call they made? A logical alternative is defined as a call that would be considered and chosen by at least a substantial minority of players of equivalent experience and ability acting on the basis of information that was legitimately available.
- 4 Did the hesitation suggest that the call chosen was preferable to the alternatives?

If the answer to all four steps is affirmative then the director should make an adjusted score. Notice the standard is "a substantial minority", not necessarily a majority, of his "peers".

Another common reason for a Director's call occurs after a claim has been made. Law 68 covers this aspect. The law states that the one making a claim will state how many tricks they will win with "... a clear statement of the order of play.". Law 70 discusses what happens if a claim is contested. A common problem is that the Claimer was not being specific in their claim, usually by stating something to the effect that "the rest are mine" without stating how the hand will be played. Often a claim is contested when the other side has a trump which is not mentioned by the claimer. A failure by the claimer to acknowledge the fact of an outstanding trump is partial evidence that they have forgotten that it is outstanding. When a claim is contested the Director is charged with adjudicating the results as equitably as possible. They must assume "normal" play by the claimer which "...includes play that would be careless or inferior for the class of player involved.".

Law 83 sets the procedure for parties to appeal a Director's decision if they are not satisfied. If an appeal is made there will be a hearing before an Appeals Committee. The Club's Board of Directors has an appointed list of members on the Appeals Committee but if there are not enough of these members present the Director can appoint others as temporary members of the Committee. Club rules stipulate that an appeal must be made to the Director of the game within 30 minutes from the end of the game. As a practical matter the appeal should be made before the end of the game to allow the Director time to set up the Committee.



# **BRUCE THIHER—OUR NEW DIRECTOR** Submitted by **Henry Hood**

**BRUCE** writes:

I started playing bridge in college at Iowa State and have now been playing for the last 48 years with some periods of intermittent playing. During the time that I lived in rural areas of the country in the Midwest, the opportunities were more limited. I did become a certified director sometime in the early 80's. It is so long ago and so far back I can't recall just exactly when it happened.

The big joy came in making Life Master at the Kansas City Nationals in 1975 when one of Cedar Rapids, Iowa's leading players took me under his wing and allowed me to hang on to his coat tails.

I arrived at The Villages in 2010 under the auspices of Bud and Loretta Harp, my lifetime friends from 45 years ago when we met across the bridge table on Okinawa, Japan. I enjoy playing 4 or 5 times a week, although that has been reduced now by regularly directing the Monday and Friday evening games at Laurel Manor. I have started baking brownies so the players will not miss the former directors quite so much. I have a feeling my culinary skills may improve as a result of directing.

Mastering the computer and all the details is a major undertaking and many thanks to the tutelage of the existing directors and to Paul for enduring endless questions.

**HENRY** adds: **Bruce** is most amusing at the bridge table and tirelessly tries to educate us. As an avid traveler, he is fluent in French and Spanish. Since moving to The Villages, he has been to Palestine twice, three trips to Poland and Germany, one to all the eastern bloc countries, and another to Africa. Bruce is a welcomed addition to our Director ranks.

# DON BAKER—NOVEMBER 13, 1933 TO DECEMBER 28, 2015 WRITTEN BY SANDRA BAKER

**Don** loved duplicate bridge so much that when we moved to Oxford in 2007, and he found out he couldn't play duplicate in The Villages, he said, "I'll buy me a damn house in The Villages then!" And he did just that so he would have a card to get into the bridge games. Every night he would read little paperback books called THE BRIDGE WORLD which said "founded in 1929 by Ely Culbertson". (I don't know who Ely was!) If the bridge magazine would arrive he would devour that in two nights and then return to his paperback books. He dragged me into duplicate bridge kicking and screaming about 2009 and I had classes from Dean Robinson and Jon Williams who were both very helpful. Every night at dinner we would discuss bridge hands. Sometimes he'd wake up in the middle of the night and figure out a way to make a hand he'd played the day before! Thankfully he didn't share it with me until the next day!

Don had an addictive personality, but by the time I met him he had given up cigarettes, his only negative addiction. We were both avid tennis players and both loved dancing when we met. Initially we thought we shared a love of bridge too, but when he played social bridge with my friends and me, it became readily apparent that we were outclassed! He became a life master at the age of 36 in 1969 in Lakeland, FL. He told me how people were mean and nasty at the bridge table—they obviously didn't have those yellow frowny-faced cards at that time! It really motivated him to study and learn the game. He always liked a challenge. Initially, none of those players would play with him, a young upstart, so there came a time when they wanted to play with him! They met at Morrisons Cafeteria, and eventually Don bought a house on the Florida Southern College campus, remodeled it, and he became the director of the Lakeland Duplicate Bridge Club. After these stories, I decided I would just drop bridge. He continued to play awhile and ran the big tournament in Orlando a couple years as I recall and then gave up on bridge since he opted to take care of his father for two years, and basically never left the house but became his full-time nurse. After his father died, and it became apparent that I had no interest in competitive bridge, he also gave it up for twenty years.

Instead, we bought 320 acres in his home state of West Virginia, and when he saw a deal on a saw mill, he bought it and loved creating the lumber which he used to build two houses, one up the mountain, and one down on the creek. His addiction to "sawing" spread to getting a bulldozer and backhoe loader so he could build a road up the mountain. Being a city girl, I had no knowledge of this machinery. I had no interest in learning to run any of them! The first time he had cancer in 2001, he said he had to get to WV to recover, and he would spend long days using the saw mill and building the roads. He DID recover from throat cancer, and the doctors considered that a miracle. They had given him six months to live.

So, he became a sawmill operator, builder, and farmer as well; we had huge gardens and shared a lot of our produce with others. Then we both became addicted to canning and dehydrating produce. With all the good food we were growing, he then became a gourmet cook. That was a wonderful addiction from my perspective. I was your basic cook and baker and he could bring in carrots from the garden and create a recipe with brown sugar, butter and amaretto that was so good it could have been served as a dessert! He was always looking up new recipes. We sold the acreage after seven years and Don surprised me by buying a big log house on the Greenbrier River with five acres, so the gardening continued. We spent six months a year in Winter Park, FL and six months in WV outside Hinton on the river.

It was 2007 when we moved to Oxford, FL to a five-acre farm. He bought that extra house in The Villages, rented it, but got The Villages ID so he could play. I felt it was semi-illegal, but he then convinced me, and after many lessons at home with bidding boxes, that I could play duplicate bridge, and I had an ID card so it was legal. In 2010 we decided acreage wasn't to our liking any more—way too much work, so he told me to start looking for a house in The Villages. By now I was used to forests and trees and it took me two years to find a house with woods behind it and lots of large old oaks. In 2013 we moved into The Villages and sold our Oxford and WV homes. So we had lived in The Villages three years when he made his transition December 28, one day after our 28<sup>th</sup> anniversary.

He played bridge until the last possible moment. His last game was on Saturday, December 12 with Sandra Gebhardt. He asked me to reserve a table nearest the coffee pot, and I asked for the table across from him. He came with his John Wayne coffee cup in his right hand and a dose of morphine in his shirt pocket! I was a nervous wreck, glancing across to see how he was holding up. He had made another game with Colleen Treanor on December 21<sup>st</sup>, but he was not doing well and entered the Hospice House the following Tuesday and asked me to cancel that game. So, duplicate bridge was one of his first and last addictions.

I would like to thank all of you who sent cards, brought food, made donations to St. Jude's Children's Hospital in his memory, and to those who came to his Celebration of Life service. Some people even offered to come over and make repairs in our home and fix things that he could no longer do and I had no earthly idea how to do. I've cried so many tears of pure gratitude, as well as a million tears of equally pure sadness. Thank you all from the bottom of my heart. I've appreciated every hug and every memory you have shared with me. It is especially hard to go play bridge and not see him, but I've made myself continue to go and play when my preference would be to stay home. In fact some of his last words to me were to keep playing bridge and teaching meditation and NOT stay home alone! Tears come at the most unexpected times...and I cry so easily, but I'm trying so hard to keep on keeping on.
