President's Report - Allen Bozek

We need to appoint a Vice President as a result of the resignation of Marie-Alice Fombrun. David Kupperman has agreed to assume that position. He has discussed a replacement of the position of Treasurer with Michael Schneider, who has agreed to become our Treasurer.

12/31 - (Joint with Quick Tricks) Monday night - New Years Eve. Plans are progressing.

House – Allen Bozek reported that roof scupper extensions were added. Air conditioner #4 required repair for coolant leak. The cost was \$472.50. This a/c may need replacing. We have an estimate of \$7,900.

Insurance – no report.

Marketing/Publicity - no report.

Membership – Robin Kupperman requested assistance by the Board to man a table at the front door to collect dues for 2019.

Nominating Committee – David Kupperman. There are now 7 candidates for the 5 positions to be filled on the Board of Governors for 2019. Ken Wagner volunteered to be a candidate as his term is ending in December. The candidates are: Michelle Ezray, Sandra Gordon, M.P. Gupta, Paul Jacobson, Loretta Neff, Michael Schneider, Ken Wagner.

Suggestions – Trudy Bell – we have a request that there be a second 0-1000 game during the week (not just Friday). Discussion that we are more in need of additional limited games, e.g., 0-100 or 0-300, which the Club Manager may present during the Season.

Teaching – Rosemary Boden reported that Neil Silverman has agreed to present his series of lessons in January, probably on Monday mornings. There will be a new event "Ask a Pro" after each weekday game. A Silver Life Master (or higher) will be available to answer questions from the less experienced players. Textbooks are now available for purchase at discounted prices. The Mentor Program continues to be well attended.

Unfinished Business

Judy Halloran reported that Edgar Hift agreed to demonstrate the use of the defibrillator for the members of the club that would like to learn about it.

New Business

Sandy Gordon brought up the situation regarding inconsistent enforcement of the no-cellphone policy. Discussion with Club Manager that it is his responsibility to see that the policy is enforced by all the Directors.

Keith Gellman announced his concern with the stratification for one particular Open game in which there were only 9 tables in each direction, and the computer's stratification had four well known A players now playing as B's. He announced after realizing the computers' needs to make the cut-offs suitable to those who are in attendance that day, that in a small (less than 9 table) game, it might be impossible for the most equitable stratification. Having said that, he switched gears, following up on the earlier remarks, that he's concerned there are not enough games for beginners to graduate to, once they are forced out of the 0-20 games. He said we're doomed if we don't grow the club, quoting membership of 1200 when he joined in 2004, and 400 today.

He urged Emilio and the board to reconsider the strata of the daily limited games, and/or to try to insure more places for newbies to play upon graduating from their 0-20 games.
