In the absence of the President, the Chairman chaired the meeting.  
In the absence of the Secretary, the Membership Secretary took the minutes.

**2. Approval of Minutes of 65<sup>th</sup> AGM**

The minutes were unanimously approved.

**3. Matters arising**

There were no matters arising.

**4. Officers' Reports**

*(Written officers' reports were circulated with the Agenda and posted on the OBA website. Additional reports presented at the meeting are now included in an updated version of that document. Items minuted here are only those which were raised at the meeting itself.)*

❖ **Chairman:** See report previously circulated.

The Chairman explained that, on returning from holiday shortly before the meeting, he regretted having to deal with numerous emails arising from disagreements between members of the OBA management teams, which in some cases had led to resignations, or threats of resignation, at very short notice. He urged everyone to treat each other with respect – we are all trying to do our best for the Association. Linked with this there were a significant number of emails concerning instances of inappropriate behaviour at the table on County Nights. He was aware that there are different perceptions of what constitutes appropriate behaviour but felt strongly that we play bridge as a hobby and we need to make it enjoyable for everyone and make them feel welcome. The following supportive message from Keith Sadler (a former OBA Chairman) was read to the meeting:-

*'I have just looked through the reports for the AGM and I would like to record my absolute pleasure at seeing the OBA thrive as well as it clearly is. I would appreciate your congratulating the whole of the management committee for their dedication and work for the year. In particular, I believe that Rob has achieved a remarkable amount and his dedication and commitment is testament to the quality*

*of his chairmanship. It is wonderful to see the amount of energy and drive that is evident from across a whole range of officers and members. Brilliant and thanks!*

Those present expressed their approval of these sentiments in the usual way.

- ❖ **Treasurer:** See report previously circulated.

The Treasurer explained that, as last year, although the list of receipts and payments was accurate, a historical accounting record of this nature produced some anomalies when comparing the accounts from year to year, because income and expenditure did not always occur in the same period as the activity to which they were related. The following specific points were made:-

- The EBU required the accounting date to be 31<sup>st</sup> March which caused some of the anomalies.
- The net profit could be regarded as £3000.
- Some Congress fees had been paid early so appeared in this year's accounts.

Chris Kerr asked if the same anomaly would occur should fees be paid early again next year. The Treasurer confirmed that this would be the case and referred to the impact of the EBU date set for submission of accounts.

The Chairman explained that in future the presentation of the accounts would be changed so that they reflected the Teams structure for the running of OBA. He circulated two additional sets of figures [*see appendix*], one showing the receipts and payments for the year analysed by team, and the other a profit and loss account including approximate adjustments in respect of items occurring in the "wrong" year. These were his own figures and had not been audited, but he believed they gave the correct picture.

The Treasurer put to the meeting that the P2P county contribution for Oxfordshire should remain at 6p. This was proposed by Alan Wilson, seconded by Stephen Brown and agreed nem.con.

The accounts were received by the meeting.

## 5. Team Reports

- ❖ **Communications and Infrastructure:** See report previously circulated. The Chairman reported that he had been asked in an email communication, to justify the use of the 'all' in the phrase '...whilst still enjoying all the functionality available on Bridgewebs' in the final sentence of the report. The

Chairman explained that whilst the scoring process was not transferable as it currently stands, he had been assured that it would be technically possible to achieve a scoring system compatible with Bridgewebs should that be required.

The Publicity Officer apologised to the catering officer Esme Alden for the late notification of entry numbers for the Mixed Pairs Competition on June 10<sup>th</sup>.

The Newsletter Editor presented his report [*now included in the compendium of officers' reports for the year*], explaining how the Newsletter had developed since he had taken on the role of Editor in April 2010. Alan Wilson warmly congratulated him on producing Newsletters more frequently and on the increased interest in them that he had generated.

❖ **County Night and Competitions:** See report previously circulated.

The Chairman expressed his disappointment at the resignation of the County Night and Competitions team leader. He said that a volunteer to lead this team is now required.

He expressed the view that all the team would share with him in thanking the resigning leader for his hard work. The team's task has been to look at the various OBA competitions to see if they are appropriate and of the right format. The Chairman had expected the task to take much longer than had proved to be the case. The changes now need to be shared with the Management Committee and with clubs before the team moves forward with plans for implementation. It may be possible for changes to be finalised in time for inclusion in the forthcoming Competitions Brochure for the new season but consultation is essential.

The Chief Tournament Director presented his report [*now included in the compendium of officers' reports for the year*], thanking those who had helped him during the year. Stuart McPhee was also thanked for directing.

A question was asked about the apparent lack of progress in replacing the County Honours. It was explained by an OBC representative that the engraving had caused a delay but that, in due course, the new boards would be available.

❖ **County Team management:**

The chair of the County Team Management team presented his report [*now included in the compendium of officers' reports for the year*], describing the results achieved by the County Teams over the year - in particular the success of the A team which had won the Midland League for the first time anyone can remember, thanking those involved, and outlining some ideas for the future.

In response to a question from Kathy Talbot, Alan Wilson informed the meeting that the deadline for responses to his questionnaire was technically the date of

today's meeting but that responses received by the end of the week would be included.

- ❖ **Education and Improvers:** See report previously circulated.

The chairman explained that, following the resignation of the previous team leader, he was temporarily running this team. He thanked Gillian Weatherly for all the work that she had done in setting up the team.

A volunteer to take over the running of this team is now required.

- ❖ **Youth and Duplicate Bridge Promotion:** See report previously circulated which includes the Membership Secretary's report.

The Chairman noted that this team leader had helpfully included a list of the team members. He suggested that all reports should, in future, include such a list.

- ❖ **Social:** See report previously circulated.

The Social team leader reported that the Social Congress now had 12 tables and that she hoped that the numbers would increase over the next few days.

The Chairman explained that prior to P2P, OBA had around 600 members and that now there were 1300. The 700 new members were the target group for the Social Team.

The Social Team Leader explained that she was seeking help from clubs in order to match the activities to the membership. Such help need not be time consuming as her principal need was for information.

The Chairman congratulated Marryat Stevens and his colleagues on the excellent progress made during the year.

**6. Substantive items for discussion**

(a) Proposed amendments to the County Constitution

The Chairman explained that since the introduction of P2P, the existing OBA constitution has not complied with EBU's approach to membership. He further explained that the proposed changes, provisionally approved by the EBU, were based on the EBU's model constitution. Since the changes had been discussed at previous Management Meetings and had been widely publicised he gave no further details but invited questions.

David Bygott sought clarification of the criteria for representing Oxfordshire. He was referred to section 4.14 which states that the OBA Competition Bylaws define Members who are eligible to represent Oxon in inter-county competitions and which explicitly states that Membership of OBA is not, in itself, sufficient qualification. The County Team Management Team would be addressing this issue as part of the review of the Bylaws (see below).

Peter Sherry proposed acceptance of the new constitution. His proposal was seconded by Sandra Claridge and passed by the meeting nem. con.

(b) Proposed amendments to the Competition Bylaws

The Competition Bylaws are referenced in the new constitution and therefore need to be amended. Kathy Talbot presented the following proposed eligibility criteria for County Competitions:

*President's Cup: members of the Association who have Oxfordshire nominated as their county of primary allegiance and maintain this allegiance throughout the event.*

*County Pairs: members of the Association who have nominated Oxfordshire as their County of Primary Allegiance.*

*Wessex League: members of clubs affiliated to OBA; in the case of non-affiliated clubs, all players must be paid up members of the OBA unless they are playing in Division 5. Players need not have Oxfordshire nominated as their county of primary allegiance.*

*For progression to the Garden Cities, an eligible team comprises that representing an affiliated club.*

*Seniors: all members of the Association who are or who will be 55 years of age in the calendar year in which they are playing; plus younger members without standing.*

*Weekly duplicate/teams events: members of the Association, plus non-members of the Association, who must pay visitors' fees.*

*The Beck Cup: invited teams comprising members of the Association.*

*All other competitions: members of the Association.*

The Chairman explained that these proposals were presented to the AGM for comment and that further consultation would follow with a view to incorporating the changes in the new season's Competitions Brochure, together with any other changes referred to in item 5 above that may have been agreed by then.
