#### DO YOU KNOW?

#### **REVOKES**

It is sad that directors are still being called in relation to revokes. The Laws were changed a couple of years ago so that if you think your partner may have revoked you should immediately ask "Having none, partner?" If you realise that you could follow suit you can immediately withdraw the incorrectly played card and substitute it with a legal card. The incorrect card becomes a major penalty card if you are a DEFENDER to be played at the first legal opportunity. Declarer can simply put the misplayed card back in his hand. (note: if you are defending and you have won a trick whilst your partner has a penalty card then Declarer has a number of options which may limit what you can lead. If you won the trick then you must lead the penalty card).

### **OPENING LEAD OUT OF TURN**

Again – this crops up too often and principally because the person making the lead does not place the card face down and ask "Any Questions?" If players did this and waited a second or so before turning over the lead card possibly one of the other three players MIGHT just notice – and as a friendly club I sincerely hope that opponents would say something as well as your partner! May I remind you all that you should NOT put away the bidding cards until the opening lead has been turned over (faced).

### **ABOUT HOWELL, BOWMAN and HESITATION MOVEMENTS**

These movements are played as they ensure fairness whether you sit EW or NS. A Full Howell is the fairest of all movements. Because the number of tables can vary, and even include a half table, it is not always possible to have a fair and an "easy" movement like a Standard Mitchell. One of the complaints against Howell movements is that they are slow but considerable time would be saved if all players at the start of the evening find out who they will be following and note where they sit each round. When it is time to

move you will then know which table to go to quickly!! It is also sometimes preferable to have a Howell movement to avoid pairs sitting out for 3 or more boards.

#### The 'MOONRAKER' 007 HAND

This hand is truly world famous. North is in 7♣ doubled and redoubled but I am sure none of you playing West would dream of doubling 7♣ - -- would you? Really?? You only have 31 points.

If you were North can you make it? (ps: where did you get the idea that you needed lots of hcp's to make a grand slam? Eight is quite sufficient!)

# **DOUBLE OF OPPONENTS 1NT OPENINGS**

Some players still seem unaware of this! If you double your opponent's 1NT opening it is expected to be for penalty and show 15+ points. If your double is for take-out **it must be alerted**. [It would be wise to agree with partner what you do if your opponents are playing a mini 1NT opening (eg 10-12) as the same rules apply – if the double is for penalty there is no alert; if it is for take-out it still has to be alerted.]
