Bad Behavior

I don't want to promote smugness, but I can tell the players of our unit that our games are exceptional for their civility and good spirits. But even here there is an occasional problem, and that's what I'd like to address.

The ACBL promotes a Zero Tolerance policy: bad behavior should be met with an immediate (though small) penalty, rather than a warning. A penalty does not mean that your opponents or the director think you are a bad person – just that a particular behavior is not permitted. As gentle as the penalty is intended to be, it is a Big Deal to the person who receives it: a person has been found guilty of an offense to the game.

As director I am frustrated when a player comes to me – frequently at the end of a game - and says that an opponent was rude at some prior point. The "offender" may already have left the game and is accused without the opportunity to offer a defense. I don't think that this kind of report can support giving a penalty, though I normally would try to discuss the problem with the person involved. It's much better if the director is called as soon as behavior becomes a problem. The purpose of the Zero Tolerance penalty is to nip bad behavior in the bud.

As a player who is disturbed. Call the director! Any behavior that makes you uncomfortable should trigger this. The director is the one who should deal with the problem. By calling at once you give the person who is bothering you a chance to give his side of the story, and you give the director the chance to hear from everyone while things are fresh in their minds, and a chance to deal with it before it gets out of hand.

If your own behavior is questioned: Do not be offended if the director is called. You'll have a chance to speak up for yourself. Suppose opponents you do not know have an auction with some "significant pauses." You ask if they agree that there were major hesitations. They are offended; they think you are questioning their integrity, and they call the director. The director may determine that your opponents are new players; he'll tell them that hesitations are part of

the game and perfectly ethical, but can create problems. You can explain that you were not suggesting that anybody's ethics might be deficient. The new players may have learned something about the game.

If you are penalized, remember that the penalty is for the behavior, and not an expression of dislike or disapproval for you. (I once gave a penalty to a sometime teammate, for discarding aces and kings to show displeasure with his partner's defense. He took it well.) An apology would go a long way and is likely to be accepted with gratitude. There is a message there, though — a behavior you may have thought was okay, isn't.

It is very bad for the game when people start "talking out of school" about some other person's behavior. Rumor-mongering is pernicious: it is one of those behaviors we most want to discourage.

Double KO Tournament Starts Second Round

Although eleven teams lost in the first round of the Unit 191 Double Knockout Tournament, all of the teams are still in contention, as a team has to lose two matches before getting knocked out of the competition.

Enthusiasm is high for this event which will extend into the summer. Second round matches must be completed by March 29th and may be played at any time or location, even in players' homes.
