President's Welcome - Vicki Willis

The meeting was called to order by Vicki Willis, President of District 10 at 6:30pm CST. All attendees were asked to introduce themselves and state the Unit and/or office that they hold.

Approval of the Minutes - Vicki Willis

A motion was made to approve the minutes for the last District 10 meeting. The minutes from January 18, 2024 were approved and uploaded on the District 10 website.

Treasurer's Report - Pat Williams

Pat Williams presented 3 documents (**Attachment #1-3**) for the meeting including the Balance sheet through 5/31/24 compared to prior year, Income statement through 5/31/24 compared to prior year and the Income statement presented by activity class through 5/31/24. There are some significant events that have occurred so far in 2024:

- Receipt of NABC online fundraising of \$12,024
- Receipt of district share of profits from the Hot Springs Village regional \$1,476 (50% to be revenue shared)
- February STaC netted \$920
- Online NAP and GNT events netted \$638 with additional expense of \$200 to be recorded in June

The District is in a good cash position with over \$100,000 with upcoming expenses including disbursement for the GNT Teams in the upcoming month totaling approximately \$8400.

Sherrie Goodman asked about Regionals and how money is distributed and whether the process is new. Patrick explained that the distribution of monies for *Stand Alone Regionals* is approximately half of the net income goes to the district and 1/2 of that amount is distributed to the units that do not hold a regional in that calendar year. The other half stays with the Unit that hosted the Regional. *Split Regionals* are different in that whatever is made locally, stays local with no revenue sharing with the District. The question was asked if this is a new process and Pat explained that 20 -25 years ago came up with the plan that not all units would hold regionals since it was in the district interest to hold regionals in larger cities so as a compromise, the smaller units would share in part of the proceeds in a revenue share. Larry Sealy mentioned that in March '24, the ACBL Board voted to eliminate Split Regionals unless the District was currently running them. District 10 has not run a Split Regional for several years. There are 3 districts that are still running Split Regionals including District 11 (Kentucky, Indiana) so they are grandfathered in. Split Regionals were originally designed where two smaller cities would have the pair games play the same deals and the results were combined from the two sites for one winner. Most districts have not been running Split Regionals.

Jerry Burford mentioned that Rob Maier asked where the proceeds from the June STAC should be going - to the unit or to District 10 and ACBL confirmed that proceeds would go to District 10 and ACBL will send a check to the District Treasurer as electronic fund transfer is not set up for the District.

A motion was made to update the District bank accounts and add Vicki Willis and remove Charles Durrin as authorized signatories. Motion was approved.

Pat explained that the District has had a money market account for years and is a low yield account and he suggested that we consider approval of certificates of deposit or other interest-bearing accounts as deemed advisable by the treasurer or the executive committee. A motion was made and approved for Pat to explore higher interest accounts and motion was approved.

Tournament Report - Susan Bridges

Susan covered the Tournament report (**Attachment #4**) as Charlie McCracken was unable to attend the meeting. There is an upcoming 3 Day Regional in Shreveport at the end of June. There are 2 Regionals planned for the fall in Nashville and Birmingham. The District is allotted 4 Open Regionals annually and we are having fewer Regionals that we are allocated. We are allocated 5 Non Life Master Regionals and those are taken and have become popular.

Susan asked the Board's feedback on 3 Day Regionals. Charlie has approved 3 Day Regional since we don't have enough Regional requests. Sherrie Goodman said that some folks in her club who travel to

tournaments would not travel for a 3 Day Regional. Since the 3 Day Regional is later this month, Susan said that attendance may be a measure for success. Larry Sealey mentioned that since we don't have enough units asking for open Regionals to fill the District allotment, a 3 day Regional is better than no Regional. One downside is that if there is competition with a 7 day regional during that time frame, players may not travel to a 3 day vs a 7 day Regional.

Larry said that tournament attendance has been flat. Gatlinburg was down slightly from last year, Cincinnati Regional was down slightly but there was a competing regional in Evansville which may have impacted attendance. Overall, tournament attendance is well below pre-pandemic levels at about 50-60% attendance.

Dan Graham asked about incorporating online games in conjunction with the face to face Regional. Pat Williams said there is an option to have one day of online games for District Membership for each District Regional. In the Fall '23 Nashville Regional, of the \$7000 netted,, \$2000 came from the online portion of the Regional. If there is an option for one day of online games during a tournament and the hosting unit doesn't want to host the online game, one option may be to have the District host the online portion of the Regional. One hurdle for hosting Regionals is for clubs that have smaller club space and they have to find venues to house the tournament. Dan asked if the online portion of the tournament is limited on how many games can be held online.. The online portion of the Regional is limited to a 2 Session Game run either vertically (morning and afternoon session) or horizontally (2 evening sessions so it doesn't compete with the face to face Regional games). It is also only available for Regionals and not Sectionals.

Sherrie Goodman asked for the Board opinion. New Orleans is planning a 5 day Regional in April (4/14-18) but wanted feedback on whether they should change it to a 6 day Regional. New Orleans is piggybacking on French Quarter Fest and feel that it would help with attendance. They also limited it to 5 days because it was during Passover and Good Friday. General agreement was that any days for Regional is better than none.

NAP/STAC Report - Jerry Burford

The most recent STAC in June was the first one to be handled with the new ACBL process where ACBL collects the fees from the clubs and then ACBL will rebate to the District. It is an easier process and avoids the District from having to collect fees from different clubs.

We've had 2 STACs so far in February and June with another STAC request pending for 8/26-9/1/24. Jerry has 3 STAC requests pending for 2025. We will also participate in the District 7 Royal STAC in December (12/9-15). Clubs have to register to participate in the STACs so remind your Club Managers to register for the STACs.

NAP/GNT Contests. District 10 did participate at the NABCs in Louisville for the NAP and there will be District 10 representatives in Toronto for the GNT in July. Jerry is developing the conditions of the contest and once ACBL approves, it will be added to the District and ACBL webpage. For the NAP contest, the events have started. Clubs are allowed up to 2 events per month for June, July and August. For NAP, District 10 requires club level qualification placing in the top 50-60% of the club game to be allowed to participate in the District Finals in January or February. Since COVID, NAP Finals have been online and virtual games have improved participation since there was no travel. Since the Finals have been online, the funds from the games go directly to the District vs when the games were face to face, the proceeds would go to the club. Jerry asked for feedback on whether to have District Finals online or Face to Face. No preference was expressed one way or another.

Larry Sealy mentioned that there is a motion coming up at the next ACBL BOD meeting in July about changing the brackets for NAP. There are currently 3 flights: 0-500, 500-2500 and 2500+ Proposed new flights 0-500, 500-3000(3500), 3000-(3500)-6000 and 6000+ Brackets will be identical to the GNT. GNT will start in September. District 10 has not required club or unit level qualifications. Any team can participate in the District finals which has increased attendance in the Finals. If 8 or more teams

participate in the B or C flights, we can send 2 teams to NABC.

Education Report - Karen Jennings

There has been one request for reimbursement from Unit 161. The request will be presented to the Executive Committee shortly. Karen wanted to remind everyone about the ACBL CAP Program that offers assistance with advertising. Additionally ACBL has a tutorial on Facebook Webinars if units want to use Facebook to advertise. Consider using NextDoor as another social media platform for potential students. There is one club has applied for a Grant with ACBL to assist with LBIAD expenses.

Recorder Report - Karen Jennings

There were 2 Discipline incidents in 2nd Quarter 2024. (**Attachment #5-6**) All of these reports and others are on the ACBL website under Ethics and Discipline and it is public information. ACBL asks that the District shares the information with the Unit secretaries and is distributed. The two reports have been shared with the Unit Secretaries.

ACBL Board of Directors Report - Larry Sealy

Larry covered a few key items from the Louisville ACBL Board of Directors Meeting. (Attachment #7). Criteria was refined for Regional Tournament Sanctioning Conflicts which is when two units/districts apply for sanctions for Regionals with overlapping dates and they are within 425 miles: Within the same District, the District President has authority to sanction or not. Within the same Region but different Districts, the Regional Director has the authority to sanction after discussion with Presidents from both Districts. Between two different Districts, the Regional Directors will discuss with District Presidents and will sanction if everyone agrees.

There was a motion to have the Fall ACBL Board Meeting virtual vs in person as well as an increase in stipend. Motion for virtual meeting failed. Agreed that meeting was more effective in person. Increased stipend from \$1000 to \$2000 per trimester passed.

Summer 2027 NABC site is being reviewed. It will most likely be Las Vegas but it has not been finalized.

Membership is down from pre-pandemic but rate of decline has slowed. There are several initiatives to improve retention and growth including the 5/5/5 plan that went into effect 4/1/24.

Currently there are Life Masters and Life Members. Life members did not have to have a paid ACBL membership and could still accrue master points. Life Members were upgraded to full membership through the end of this year. At the end of the year, Life Members will have to renew their membership or they will no longer be able to accrue master points.

Usage of EDGAR (Everyone Deserves a Game Above Reproach) began 2/1/24. With a new roll-out, there were some learnings that led to some changes including discipline being formulated on each master point level, heightened scrutiny for Unit/District Officers, players who cheat with multiple partners will receive more discipline. Details on EDGAR categories, fast track discipline warnings and stats can be found in the attached ACBL BOD presentation.

New/Old Business - Vicki Willis

Old Business - none

New Business - Vicki had a suggestion that clubs start 8 is Enough games. New Orleans is very experienced with this type of game and it's been very successful so if you are interested in starting

these games, reach out to Vicki. The premise of 8 is Enough is that a team is built with 4 players in different Master point ranges. <100 mp = 1 point; 100-1000 = 2 points; 1000+ = 3 points. The total of the 4 players must equal 8 or less. The purpose is to get players comfortable playing in the Swiss Team game format.

Pat Williams mentioned that we need to seat a 5th member of the Executive Committee to replace Chuck Wilkinson. In the past, the executive Committee members consisted of the President, Vice President, Treasurer, Immediate Past President and a Board Member. The Secretary was nominated to be on the executive committee but currently, the Treasurer and Secretary are from the same Unit and bylaws prohibit two people from the same unit to serve on the Executive Committee. Dan Graham was nominated to be on the Executive Committee and appointed unanimously.

Sherri Kinkopf is the new editor of the D10 newsletter and asked the Units to send any news to Sherri. She has been checking Facebook units and club accounts, Unit websites, etc. for information. She wants to highlight successes around the District. Since a lot of clubs have newsletters, Dan Graham suggested that the clubs include Sherri on their newsletter distribution.

- 3. serving an indefinite Probation;
- 4. serving a Probation, the initial term of which was 24 or more months; or
- 5. serving a term of Probation following a Suspension, the initial term of which was more than 90 days.

A member who is not in good standing may not:

- 1. Serve in any elected or appointed position in ACBL;
- 2. Receive any subsidy or remuneration from ACBL;
- 3. Participate in Masterpoint races;

- 4. Receive recognition for Masterpoint rank promotion;
- 5. Publish an article in any ACBL publication;
- 6. Vote in any election in which general membership is electorate;
- 7. Serve as a club manager or director;
- 8. Participate in events where such participation is prohibited by Conditions of Contest;
- 9. Vote in a Hall of Fame election; and/or 10. Membership on the Goodwill Committee.

Key Actions from Louisville NABC (1 of 3)

Refined Criteria for Regional Tournament Sanctioning
 Conflicts (<425 miles, "as the crow flies") ○ If within the
 same District, the District President has authority to sanction or
 not ○ If within same Region, but different Districts, the Regional
 Director (upon discussing with the Presidents of the involved
 Districts will decide. ○ If involving 2 different Regions, RDs will
 discuss with District Presidents and sanction only if all agree. ○
 Otherwise, the sanctioned tournament with the "traditional date"
 or the earliest previously sanctioned tournament prevails

Board Expenses and Meetings

- It was proposed to hold Fall BOD Meetings virtually (rather than before the Fall NABC) and increase the BOD member stipends from \$1000 to \$2000 per trimester was proposed.
- A motion to sever these two items was approved and they were voted on individually
- The new motion to hold the Fall BOD Meeting virtually failed, as many thought it was too important to conduct this meeting (where the next year's budget is voted on) in person. ○ The motion to increase the stipend passed. ○ I voted against both motions.

Advisory Council Clubs and Teachers Committee

- This motion was to create and codify a Committee of the Corporation to advise Management and the Board of Directors on decisions that materially affect clubs and teachers
- This motion failed unanimously, as Management thought it was redundant with the newly initiated Club Task Force.

Key Actions from Louisville NABC (2 of 3)

 Summer 2027 NABC Site Narrowed down to Chicago or Las Vegas. Management (coordinating with Site Selection Committee) given Authority to decide.

Finance:

YTD results better than expected (>\$100K) ○ Budget for FY2024
 projected net loss of \$313K. Hopefully, it will be a little better. ○
 Balance sheet is strong

- Membership is down to 130,000 but the rate of decline has slowed.
 - Management has been working several initiatives to try to reverse, including the new 5/5/5 program that went into effect Apri 1.
- We began tasking The EDGAR Association (TEA) to screen online players on Feb 1.
 - Details will be shown in later charts
- The Life Member Category will be eliminated at the end of this year
 - Existing (unpaid) Life Members have been upgraded to full membership through the end of the year. At that point they will have to renew or will not earn Masterpoints®.
 - Many Life Members have not signed the Arbitration Clause, which is a possible issue with discipline.

Key Actions from Louisville NABC (3 of 3)

- All Covid Protocols Eliminated as of May 13, 2024
- Possible addition of another Flight for NAP or

We have 4 Flights for GNT. The thought was to mirror those with NAP. ○ The limits for each Flight may be increased somewhat (e.g., Flt B may go to 3000 or 3500).

- There would be an increase in expense due to the stipends given to 1st and 2nd place. It is hoped that some of this may be made up with increased attendance.
- It was desired to do this beginning next year (IT issues need to be worked). More work will be done for Toronto.

Post-Louisville Update

- Some unforeseen issues and lessons learned from the initial EDGAR roll-out resulted in a need to update the CDR again.
- We held 2 Informal Meetings (Apr 24 and May 2) to Discuss Possible Changes.

Key Changes:

 Discipline now based on each player's MP level (previously based on higher of theirs and their partner's)
 Only Unit/District officers (Pres, VP, Sec'y, Treasure, District Recorder) will be subject to Heightened Scrutiny and accompanying discipline enhancement. Players who cheat with multiple partners will receive more discipline (50% increase) than those who only cheat with one.

Computer Based Cheating Detection Discipline (1 of 2)

- ONR proceeds with Charges against "Red" Players/Pairs
- · "Yellows" are to be Investigated further
- Fast Track Discipline (FTD) for Players with under 2500
 MPs (including Eligibility Points) who do not have any of the following Aggravating Conditions:
 - O Unit/District officers
 Or previous member of
 ACBL BOD Previously
 found responsible for an ethical violation under
 the CDR Have 5 or
 more Platinum Points

- FTD is an automated process. The Player(s) either accept(s) the Discipline or Files with Institute for Bridge Arbitration (IBA)
- Warnings are given below 300 MPs. Suspensions range from 6 months to 2 years. Probation is 4 years for all.
- Players can get their FTD penalties reduced in half by Completing the Ethics Certification/Fair Play Pledge (EC/FPP).
- An Automatic 50% increase in Discipline is Applied for Cheating with Multiple Partners.

Computer Based Cheating Detection Discipline (2 of 2)

- Players/Pairs not Eligible for FTD are taken to IBA*, unless they accept a Negotiated Resolution.
 - * If a player/pair is unresponsive to emails/call, snail mail, Mgmt may hold an in-house Expedited Disciplinary Proceeding (EDP).
- In most cases, Players will be Prohibited from Playing with any Partner with whom they Cheated during their Probation.
- NRs will Require Completion of EC/FPP and Admission of Responsibility.
- Players are Screened from 2020-on.
