the board to consider. Following are some of these motions.

**Regionals at Sea:** This motion seeks to regulate who may sponsor a Regional at Sea (RAS). The motions sets mileage limitations and requires that 50% of all profits go to an ACBL Fund or a 501(c) (3) organization. I am the chair of the committee that will review this motion. As written, I am against it. I believe that a district that wants to run a RAS should have that option.

**Preempt Pre-Alert Elimination:** This motion will eliminate the requirement for a pre-alert for short 5-card weak 2's and 6-card 3-level preempts. The board is waiting for input from the Competitions and

Convention Committee as to this motion.

**Mini-Spangold Flight II (0-1500) Knockouts:** This motion eliminates the requirement that the event must conclude in five days. By eliminating the five-day rule, more teams will be able to survive past the first day.

**Senior Mixed Pairs:** This motion would establish a Senior Mixed Pairs at the Fall NABC. Presently there is only one senior event at the Fall NABC, the senior KO, and there are no mixed NABC championships.

**Oil Leakage Disaster Charity Day:** Just after the BP oil disaster began, I suggested to the board in an email that since we were going to have the Summer NABC in New Orleans, we should make a donation to some

charity organization associated with helping with the problems. I felt that it would be a good thing to do and would garner positive publicity for bridge. After much discussion, this motion was made to make September 13, Oil Leakage Disaster Charity Day.

**It Is A Different View From Dummy**



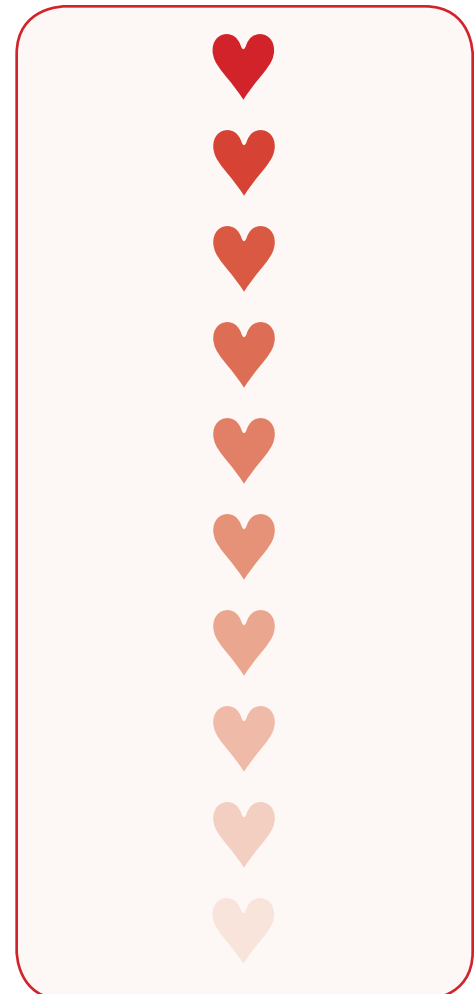

The Pasadena Regional Tournament was a roaring success. Eighteen hundred tables competed in the seven-day event. It was also reported that bridge is on the upswing at university campuses. There is much more interest in the game than in the past, possibly not as high as in our college days but it is on the rise. Free bridge lessons are available at the AV Club. Another bit of good news is that Colin MacDougal is home and recovering well from a bout of pneumonia. He responded well to treatment and is expected to make a complete recovery.

The white board on the north wall of AVBC is dedicated to a current calendar and to post new events with detailed information. Make it a habit to check out that particular white board every time you are in the clubroom. Unit games are scheduled every third Sunday of the month. Lunch is served at 12:30 and the game begins promptly at 1:00 pm. The regular unit game is scheduled for August 15. September 16 will be an Instant Match Point awarding a minimum of one gold point to the winner. October 17 is also a unit game featuring Eight is Enough. Eight is Enough is a Swiss Team event featuring four rated players totaling eight or fewer points. The rating scale is 0-750 = 1 point,

751-1200 = 2 points and 1201-to infinity = 3 points. It is a rather interesting team game and the results are unpredictable. Regular card fees will apply.

Amr Elghamry played with Mark Hartzell and teamed with our sometime director Arleen Harvey and her husband, Jonathan Harvey, to win a Bracket III Knockout. Way to go!

The John Waken Sectional is at the end of July, and once again it will be at La Salle High School on the eastern side of Pasadena, close to Sierra Madre. If you need a partner, please let me know. My friend, Teri Atkinson, will be handling the duties but she is a long distance call, so if you let me know, I'll get her the information and we'll match you up. We are trying something new for Friday night; it's a Jackpot game where a 70% score will win \$50.

Coming up is our Eight Is Enough annual game and it's time to put your team together. It works like this: no team can have more than eight points and the points are determined by the team's masterpoint levels. Players with 0 – 750 MP = 1, and players with 751-2,000 MP = 2. Those with more than 2,000 MP = 3. Any combination of four players whose point total equals eight or less can form a team. The price is right, too, only \$5. It serves as our August unit game and I'm looking forward to seeing you there. The game will be at the San Marino Bridge Club on August 8 and lunch will be available.

News from the Arcadia Bridge Center – two North American Pairs games will be held in August with the first one on Tuesday, August 17 at 7:15 and the second on Friday, August 20 at 7:30.

The Bridge Center will be closed on the following dates in August: 1, 8, 13, 14, and 15.

The ever popular Beat the House night will be on Friday, August 27 and if you were either first or last in a

game in July you can play in the Winner – Loser game on Sunday, August 22 at 1:00.

There are some terrific players at the Bridge Center, and the evidence is the quality of play. There were three games better than 70% recorded in July, and the highest was by Marv and Mark Sackett who had a 76.19% score. Congratulations, gentlemen! Now, how would you like to have a 73.21% game and come in second? It happened to John Kambe and Ted Maesaki who were beat by David and Eleanor Edwards. The Edwards scored an impressive 74.01% in the same direction.

Here's a bidding agreement you might consider: When an opponent shows a two-suited hand, you can cue bid either one, right? If you cue bid the lower ranking of the enemy suit you are showing both of the other two suits, but your lower ranking suit is the better one. Conversely, if you cue bid your opponent's higher ranking suit then your higher ranking suit is the better quality of your two suits. Here's an example - your RHO opens two diamonds, alerted as Flannery, which shows five hearts and four spades. You have a good hand with both minors, but your diamond suit is the better of them.

Cue bid three spades. If your better suit was clubs, you would cue bid three hearts. Here's another example: Your partner opens one club and the next hand jumps to two notrump which is an Unusual Notrump bid showing the two lower unbid suits, diamonds and hearts. If you have both black suits, and your spades are better, cue bid three hearts. Cue bid three diamonds if your clubs are better.

## New Effort to Start a Youth Bridge Program

The Pasadena Educational Foundation, a nonprofit organization which seeks to increase community support for the public schools of Altadena, Pasadena, and Sierra Madre, has expressed an interest in adding ACBL's Youth Bridge to its available programs.

Studies have shown that students who regularly play bridge do better on their test scores in math, science, languages, and reading.

We believe that we can provide our local students these same benefits through a district-sponsored Youth Bridge program.

ACBL funds the School Bridge Lesson Program (SBLP), which has been in existence for over 18 years. It provides practical assistance to bridge players teaching bridge in after-school programs. *Two of my regular partners, playing together, had a discussion about whether 2♥ or 1NT was best by this passed hand. The discussion ended when we asked Marshall Miles what he would do, and he answered he would bid Drury. Everyone laughed. Let's hear from the 1NT camp.*

**Meyers:** 1NT. My suit is too flimsy to bid 2♥. I have spade support of sorts, and if we belong in a game, I expect partner to bid over 1NT. (I also don't want to punish partner for opening light in 3rd chair, in which case, 1NT may be the limit of the hand.)

**Eisenberg:** 1NT. I'll follow with 2NT over 2♣.

**Sachs:** 1NT. An argument could be made for any of three bids: 2♥, 2♣, and 1NT. I play a version of Drury, so 2♣ is out. 1NT will not miss any nine-card heart fits, because partner, with 5-4 in majors, will always bid 2♥ over 1NT even with a very minimum hand. 2♥ will cause us to play there when other contracts are better.

**Goldsmith:** 1NT. WTP? If partner bids 2♣, I'll bid 3♣. If he bids 2♦, I am almost worth 2NT, but I'll bid it anyway. If he bids 2♥, I have an easy 4♦ bid. If he bids 2♠, I'll try game on the theory that he didn't open 2♠, so this should be enough. If he passes 1NT, I might regret missing a 5-3 heart fit, but I'll probably make 1NT, and if I don't, and if the other table somehow finds 2♥, I've lost 4 IMPs. Big deal.

*Now the 2♥ bidders can have a chance.*

**Wittes:** 2♥. I'd like to have a better suit, but this seems to describe my strength pretty well as a passed hand. I don't expect partner to pass with a stiff heart, since I couldn't open 2♥.

**Chernoff:** 2♥. I probably would have opened 1♥, but it's close.

**Grabel:** 2♥. As a passed hand, I can't get into too much trouble. Partner knows I didn't open a weak 2-bid, so he ought to play me for five hearts. Admittedly, they could be better, but then, partner hasn't passed yet.

**Davis:** 2♥. When partner has 14+ HCP, either 1NT or 2♥ is likely to lead to the best game, because partner and I will bid again. The advantages of responding 2♥ are that it may be a safer part-score than 1NT, and partner may be able to raise, allowing us to reach game when we would otherwise have played in 1NT, for example, if he has ♠xxxxx ♥AKx ♦Axx ♣JT. The disadvantage of bidding 2♥ is that partner with a minimum hand will (should) often pass 2♥ with a singleton (unless he has extra spade length or strength), and that will create a minus score, since I have 4+ heart losers opposite most singletons. It is worth noting that even though I am a passed hand, I am still responsible for having a reasonable quality suit if it is only five cards long, and I could also hold a six-card suit that was not appropriate for a weak 2-bid. The advantage of 1NT is that we are a favorite to make it if partner passes. The disadvantage of 1NT is that we could go down in 1NT when we were getting a plus score in hearts. We might also miss a 5-3 heart fit if partner bids over 1NT (depending on our methods after opener's rebid opposite a 1NT response). Everything considered, I think 2♥ will work out slightly better than 1NT in the long run.

*My own feeling is that I slightly prefer 2♥. It's not the only way to uncover a 5-3 fit, but it's the easiest. The gain barely outweighs the risk.*

Speak up if you dislike 4♣, but given the conditions, what now?

**First, what is the normal expert agreement about 4♣ without any discussion?**

**Sachs: 6♣.** The default expert agreement about 4♣ is that it shows a strong two suiter. I bid 6♣, because partner's pass of 6♣ is encouraging. If partner has extreme shortness in spades, he can bid 7♣ for my other suit. ♠x ♥KJxxx ♦KJxx ♣xxx is about right for him to bid on over 6♣. 6♣ says my spades are very good.

**Do we expect partner to have something useful for us?**

**Eisenberg: 6♣.** I expect partner to double with negative values.

*He thinks that partner's pass shows some values. One opponent is a preemptor, and the other opponent is a passed hand. They must be saving at this vulnerability, so partner's pass is forcing, showing some values. At the table partner held ♠Jxx ♥Kxxx ♦KJT9x ♣J.*

**Grabel: 6♣.** This might make 6♣ but not 6♦ opposite doubletons in each pointed suit. For example, ♠Jx ♥xxxxxxx ♦Jx ♣xx [not enough to pass in my estimation], would be very unlucky to go down in 6♣. We may miss a grand, but that's why they preempt.

**Chernoff: 6♦.** I don't like 4♣, but there really is no other choice. Obviously, I'll convert partner's 6♥ to 6♣.

**Wittes: 6♣.** It wouldn't take much from partner for us to be cold for 7♦ or 7♠, but with the auction that has taken place, this seems like the safest bid at this juncture. I don't object terribly to the 4♣ bid, but at

this vulnerability, the subsequent auction was not completely unpredictable. Perhaps the hand is worth a 5♣ or even 6♣ bid over 3♣.

**Davis: 6♦/6♣.** If 4♣ must be two suits, then I'll bid 6♦. If 4♣ could be a one-suiter, then I'll bid 6♣.

*Goldsmith and Meyers have conventional understandings which appear to be improvements over standard in this auction. They give up using 4♦ as natural. Not having a natural 4♦ bid here seems like a small price to pay to gain a good convention. A hand which wants to bid 4♦ can choose between 5♦, 3NT, 3♦, and double. Goldsmith uses 4♦ to show hearts and diamonds, so 4♣ shows spades and a red suit. Meyers uses 4♦ to show the majors, and 4♣ shows diamonds and a major. Goldsmith's way is a little less costly if forgotten. Goldsmith's way also may have an occasional technical gain if responder has something like 1-5-2-5 with a poor hand.*

**Goldsmith: 6♦.** What else other than 4♣? Without express agreement, it just shows a big two-suiter, though, of course, not necessarily this big. It's better to play that 4♣ is spades and a red suit, and 4♦ is the reds; that will allow you to untangle your fits most of the time. Losing a natural 4♦ isn't so bad; usually, you'll just bid 3NT anyway with the hands that might bid 4♦. Anyway, partner's pass is forcing, so he should have some useful values. Since he could have ♠x ♥KJxxx ♦Kxxxx ♣xx or ♠Jxxx ♥AQxxxx ♦xx ♣x, anything other than 6♦ seems wrong. If he has the second hand, he'll correct to 6♥, and I'll re-correct. Yes, we may be cold for a grand, but I don't like guessing at the seven-level. I'll definitely try a forcing pass if available when they save, but I don't expect

that to happen, even though I suspect their save is profitable. If I have to commit at the seven-level, I'll probably take the push, because I suspect their save is so cheap that the IMP odds will make it right to bid.

**Meyers:** 6♦. My conventional understanding with partners is that 4♣ shows diamonds and a major (and 4♦ shows majors), but if I did not have that understanding, I would assume 4♣ shows any two suiter, and if that is

the case, I would now bid 6♦. Partner should correct to 6♥ with preference for either major, and I could then correct to 6♠.

*My partner held the big hand at our table. He bid 6♦ and made seven. Our counterparts bid 4♦ (alerted but my teammates didn't ask). Over the forcing pass, the big hand bid 6♠, and the little hand thought for a long time before bidding 7♦, making.*

What call do you make?

**Grabel:** 5♣. This might be cold for 6♣ or be cold for 6♥ with little play for 6♣ but again, that's why preempts are effective.

**Chernoff:** 5♣. Color me yellow. Maybe I'll get another chance.

**Davis:** 5♣. Just a slight preference for 5♣ rather than 6♣. I'd bid 4NT if it means I have a good 5♣ bid, but it is, alas, undiscussed.

**Meyers:** 5♣. 4NT should show two places to play, but I don't really want to play in another place besides clubs; if partner has 5-3-4-1 distribution, I would still rather play 5♣ than 5♥.

**Goldsmith:** 5♣. 4♥ is tempting, but 100 honors seventh is more tempting. *[Young man, you'll learn your honors don't count at duplicate!]* It wouldn't shock me if double were the winner, but it also wouldn't shock me to go -710, either. That score is much harder to accomplish in 5♣.

**Wittes:** 5♣. It is conceivable partner may want to penalize 4♦, but with this distribution, I'm not going to reopen with a double. We could also have a slam with the right minimum cards from partner, but I'm too old and too pessimistic to look for miracles.

**Eisenberg:** 6♣. Unanimous?

*Not a good prediction Billy (you'll do much better on your prediction for #5), although Leo Bell held this hand at the table and thought 6♣ was automatic. Partner held ♥QJxx and ♠xxx, but 6♣ failed when the club finesse into the preemptor lost.*

**Sachs:** Double. Sometimes pre-empts work, sometimes spectacularly. Over 4♠ by partner, I will bid 5 or 6 clubs. Over 4♥, I will bid 6♥. And over pass by partner, I will regret my double unless we beat them by more than the value of a game.

*I'm not sure I'd be enthusiastic about defending 4♦ doubled.*

What call do you make?

*Some invite in spades.*

**Eisenberg:** 3♠. I can still bid 4♥ over 3NT.

**Grabel:** 3♠. This is a bit of a crapshoot, but I'd bid 4♠ before bidding 3♥, and I'm doing neither. Partner knows the vulnerability and will strain to bid.

Some invite in hearts.

**Wittes:** 3♥. As a general rule, I usually insist on playing in my seven-card suit, but with 109x and Kx in partner's suits, unless partner has Jx or better in spades, if there is a game on the hand, hearts seems the most likely place.

*Some bid game in spades.*

**Chernoff:** 4♠. Could make even opposite a void. A pox on anyone who bids hearts.

*Some bid game in hearts.*

**Meyers:** 4♥. With a vulnerable game available, I'll take a shot. I love my ♦Kx.

*Some force to game, probably in spades.*

**Davis:** 3♣. I'm going to bid a game in spades unless partner shows strong interest in hearts and none in spades, e.g. ...3♣-3♥, 3♣-3NT, over which I'll correct to 4♥. I could just jump to 3♠ (invitational) or 4♠ over 2♣, but, once in a while, hearts will be better.

**Sachs:** 3♣. Ugly, but what else am I to do? We belong in at least game. ("At least?" you say? I say partner has ♠Ax ♥Axxxx ♦AQJx ♣xx or ♠Ax ♥KQJxx ♦Axxx ♣xx.) On the other hand, we may belong in just game, but which strain? Perhaps 3♣ will elicit some indication. Over partner's 3NT, I will expect a singleton spade and bid 4♥ and hope for the best.

*One takes the low road.*

**Goldsmith:** 2♠. I bid that at the table and it didn't work out when spades were 4-1. On the other hand, I didn't get doubled and it's not hard to beat 2♥.

*I was Goldsmith's teammate and watched my RHO try 3♠. The actual layout is foul. (♠AJT8 is behind you.) Anything past the one-level should be down. 4♠ gets doubled for down three. I told my opponent that I thought 3♠ was a thoughtful bid. His partner disagreed, preferring 2♠.*

What call do you make?

*This hand originally came from an IMP match. I deliberately changed the problem to matchpoints, because I thought that would make it more interesting. Wrong! It turned out not to be much of a problem. At the table, however, neither player who held this hand bid the panelists' choice, 1NT. I passed. My excuse was that my partner was ultra-aggressive. My counterpart raised 1♠ to 2♠. The panel wasn't tempted by the 4-3 spade fit, preferring the normal 1NT. On the actual deal, partner has a 4144 17 HCP hand. 3NT will fail on double dummy defense, but will make if the defense slips at all.*

**Goldsmith:** 1NT. WTP? Do I really expect 1♠ to be better than 1NT? It might be, but I'm not willing to bet a full board on it. Partner can still have an 18-count, so passing is dangerous. The only other alternative is 2♠, and I don't like that at all. If partner bids 4♠, do you think he's going to be happy with this dummy?

**Wittes:** 1NT. I am perhaps a little too good for this auction, but it is an adequate description of my hand, and leaves the most room for another bid from partner, if their hand warrants one.

**Grabel:** 1NT. So... what happens to cause the problem?

**Chernoff:** 1NT. What else?

**Davis:** 1NT. This seems clear.

**Meyers:** 1NT. I have no reason to raise to 2♠ on a three-card suit.

**Eisenberg:** 1NT. This will be the popular choice.

*Good prediction, Billy!*

**Sachs:** 1NT. At matchpoints, look for plus scores; at IMPs look for games, especially when vulnerable. If partner bids 2♥ over 1NT, I will bid 4♥. [Sachs plays that sequence shows extras. I agree, but not everyone does.] At IMPs, I would bid 2♠.
