### WELCOME AND INTRODUCTIONS

## **Financial Report**

# **Banking Resolution**

Wells Fargo maintains the unit's checking account. The official name of our organization needs to be corrected but Wells Fargo has Nancy Motes as the "owner/controller" of the account. They require a resolution from the board to change the "owner/controller" and change the official name.

<u>Resolution</u>: Nancy Motes is no longer active in our organization and her name needs to be removed as our accounts "owner/controller". David Newcomer is the Treasurer

of our organization and Wells Fargo should recognize him as the "owner/controller" of our checking account. David Newcomer has permission to correct the name of our organization to our legal name.

The resolution passed unanimously and all active board members signed the document.

### PRESIDENT'S REPORT
