Minutes from last Annual General Meeting held on 4th January 2024

MATTERS ARISING

- 1. Accounts At the 2024 AGM Claire had asked Richard if it would help him to hold the AGM a couple of weeks later in order for him to have accounts to hand. Richard said then it wasn't a problem and having them ready for the 2025 AGM was okay too.
- 2. Bidding cards New bidding cards were purchased for the club and agreed by the 2024 committee.
- 3. Charities Two charities were supported with £100 each going to It's A Big Deal and Children In Need.
- 4. Keys The tennis club had sorted the storeroom's door lock and purchased new keys for us.

There was nothing further to report. The minutes were proposed by Ruth Street and seconded by Steve Bradley.

CHAIRS REPORT - Sue Gray

It has continued to be another very good year for the club building on last years increased membership, new faces and a really good turnout for all the sessions. We seem to be bucking the trend being seen at other clubs in the county which is very encouraging. This has been helped by the WhatsApp page run by Claire to get partners at short notice.

The most satisfying element continues to be the consistently high number of tables each session and the dramatic up take for Tuesday afternoon bridge. A big thanks to members who run these sessions. It is an area we need to continue to support, and I hope to see more people feeling they can become involved in the running of them. A special thanks to Linda who has done the lion's share of these (except when she's off gallivanting

across the globe). There has been a subtle change in that fixed partnerships have emerged. This may be as a result of the numbers wanting to play and the fact that we don't have those new to bridge in the same numbers.

In September we joined the EBU It's a Big Deal in aid of Cancer Research UK. Claire organised a lovely lunch followed by bridge. The total as of 3rd January stood at £125,659.29. As a club we have raised £585 this year which is marvellous. £200 was donated by the club. We also supported ECATS Children In Need event and as of December 2024 the amount raised was £61,048.

We decided to repeat Xmas lunch on a Tuesday again this year. Yet again, this was very well supported with 9 tables enjoying a lovely buffet lunch and an afternoon playing bridge. Many thanks to Claire who organised it all.

County and EBU competitions have been supported again this year and as The Competition Secretary's report will show, we have done rather well in all the events we entered. This is very encouraging and I hope dispels the myth that you have to be a world class bridge player to enter these types of competitions. The club pays the fees for each member entering these events. We have also seen many of our members climbing the master point lists and it is most gratifying to recognise and celebrate these achievements as a club. We continue to have a presence at county run events with Sally and Louise frequently attending them and having some successful outcomes.

As always, many thanks to the committee and members for their support throughout the year, it is greatly appreciated. A special thanks to Pete and Janet who have regularly taken on the task of setting up the room for each session.

As you can see from the comparison sheet we were still feeling the effects of Covid in 2022 where subscriptions were only 63% of the 2024 level and we had the double whammy of large expenditure then, making our bank balance shrink to £5260. I'm glad to say that now the bank balance is well over £9500.

The good news is that 2024 was another year where we made a surplus. This time it was £1485 which was nearly half the surplus of 2023 but difference was mainly due to the fact that we didn't run any lessons last year which had proved to be rather fruitful. So, the actual full time members were nearly the same as 2023 and we had a small rise in table money of just over £50 which was helped by the success of the Tuesday session.

We spent less on equipment last year (down by nearly £500) and we increased our charity efforts by £300, which also includes free table money to all full time members for all the EBU events during the year. So, all in all, it was a satisfactory year and unless we feel the need to spend money on something major, there should be no necessity to increase the fees for the coming year.

Sue said we were not looking to increase the subscription this year but needed to make sure there is always sufficient funds in case of increases in rent, EBU fees. In 2024 Sue said we had 39 full members and 16 part members. Richard said the numbers had been fairly stable over the last two years. The higher numbers in previous years was as a result of those taking lessons and joining for the duration of the course. Few renewed their membership.

Richard asked for subs to be paid by end of January 2025. John said it was good to keep a reserve of funds in the account too.

Sue thanked Richard for his report which was proposed by Claire Rylott and seconded by Ruth Street.
