

Summary of actions and policies required by this assessment.

Timing of sessions

- There will be two sessions a week, Monday and Thursday Afternoons allowing furniture to be “quarantined” for at least 72 hours between session



Layout of the room/limitation of numbers of attendees

- The playing room capacity, normally ten tables, will be reduced to four tables.

Provision of Equipment

- Designated container for collection of prepaid tickets will be provided
- Any prepaid tickets to be collected will be quarantined or disinfected.
- Club will organise table cloths, sixteen bidding boxes, and table number markers into two complete separate sets. One set to be used on Mondays and the other set to be used on Thursdays. Each set quarantined for a week before re-use.
- Club will organise duplicate boards into four sets of 24 boards. Each redealt and stored in quarantine for a week before it is used.
- Procure disposable gloves, hand sanitising gel and anti-septic wipes
- Club will organise scoring tablets into four sets of four. Each set will be cleaned recharged and stored such that each set has been quarantined for a week before it is used.

Check vaccination records of each player booking for the first time after 16th May 2021

Brief players before the session

- Players will be asked to stay away if particularly vulnerable to infection, if feeling unwell, if living with, or in a bubble with, persons feeling unwell, if presently instructed or advised to self-isolate.
- Admission will be available to fully paid up members only.
- Player numbers are strictly limited. Admission will be by previously confirmed reservation.

- Collection of pre-paid tickets will be only available by agreement in advance and only to pre-booked players (no casual collection)
- No cash will be taken during the session. Paying for admission will be either by transferring individual table money, or by dropping a prepaid ticket into a designated container. Prepaid tickets will not be sold at the session.
- There will be no catering, Players should bring, and take away, any drinks and drinking vessels they require with them
- Explain spacing in the car park
- Explain provision for coats, hats etc.
- Explain provisions for toilet use
- Instruct players to maintain social distance at all time. Explain provision for marshalling upon arrival, during movements, and on leaving the venue
- Ask players to wear face coverings whilst moving into, out of and about the playing room and toilets
- Explain provision for handling boards, cards, bidding boxes and scorers. North only to touch scoring tablet. North only to take boards from the bag and return boards to the bag. East / West to take their bidding boxes when moving.

Selection of movement

- Pairs movements with up to one hesitation table permitting five rounds will be used.

These moves will be marshalled to keep the maximum distance between the East/West pairs as they move. Players will be instructed to give the North/South pairs as wide a distance as possible.

Set up events in Bridgewebs

- Set up as subject to reservation.
- Set up the reservation system
- Ask each player to confirm health status, understanding of instruction and acceptance of residual risk
- Monitor reservations

Preparing the venue for each session

- Use any available cones to take alternate car park spaces out of use
- Mark queuing area by table number



- Prop doors open where possible, [to avoid touching](#)
 - [Open windows where possible to maximise ventilation](#)
 - Wipe down hard surfaces with antiseptic wipes
 - Scoring lap top and router will be set up in the kitchen area.
 - Some coat hooks will be marked “out of use”. Plastic containers for coats, hats etc will be placed around the room.
 - Check toilets for paper, sanitised hand wash and place antiseptic wipes
 - Receptacle for pre-paid tickets placed by the door.
 - Pre-paid tickets for collection, clearly labelled, placed by the door. (Better posted out)
- [Use largest available tables.](#) Tables will be positioned as far apart as possible, (See diagram above)
 - Each playing table will be covered with a cloth, screens will be positioned on each table, number cubes will be placed, and bidding boxes positioned on each side of the table, and bags of deals placed by the North seat. All done using disposable gloves.

- One set of boards will be placed, next to each North seat,
- Players withdraw, count, sort, play and return their own hands to their pocket in the board, keeping the cards in their section of the playing table.

Managing Events

- On entry marshal queue
- Administer hand gel
- Move players by table number starting with Table 1 East/West moving to kitchen area
- At end of event marshal exit by table number
