**1 Minutes of the last meeting on 2 December 2025**

These were agreed, subject to 'Pater' changing to 'Peter'. It was also agreed that Jill should add the November and December minutes when ready to the website and that Guy should send them to her as PDF's. **[ACT Guy, Jill]**

**2 Matters arising**

**2a** Guy has contacted the Community Centre over the inter area dates for next year. They would like confirmation which ones we will need but this will have to wait for the NEBA schedule to be decided. **[ACT Marion, Guy]**

**2b** The Christmas Party was less well attended than usual due to its proximity to Christmas as a result of the inter area schedule. JA suggested we might change to a New Year Party next time.

**3 Finance (Steve R)**

The club has £5,000 in savings account and £500 in the current account, with some £500 still to pay out. This is due to various expenses including £418 for the Christmas Party, £750 for the inter area and £578 for director training though some or all of this will be refunded by the EBU eventually. Steve R asked Guy for the hours booked for the Chronicle Cup semifinal and suggested £2 a head for refreshments. The costs will be reimbursed by NEBA. **[Act Guy]**

**4 Membership (Susan)**

Two new members have joined the club and two more rejoined. Fedai wishes to join but has no partner. It was agreed we should accept his membership and try to find him someone to play with, perhaps one of the students or ex-students.

**5 Mondays (Peter)**

We have been seeing between 8 and 9 tables recently, rather fewer than before. Peter proposed dates as follows:

Arnold Deane Handicap 11 May; Manny Silver and Steve Ray Cups 1 June; Captain's Charity Pairs 15 June; AGM 29 June; and Prize Giving 6 July. These were agreed, though not everyone will be able to go to all these events.

**6 Wednesdays (Peter)**

**9 Charity pairs**

The Hall is booked from 1.30 to 5.30 on 17 May and 22 November [added by GH after the meeting]. For May, we will charge £10 per person, aiming for players of NGS 9 or lower. Any surplus will go to St Oswalds and we will also take donations on the day. Jill will produce some flyers to use with the student groups, our Club and other local Clubs. Susan will source food from CostCo with cakes to be provided by the WI if possible. **[ACT Peter, Jill, Susan]**

**10 Communication**

It was reported that a Brunton member who also plays competitively for another club had circulated an email referring to the possibility of Brunton teams being relegated and indicating that such an outcome would be welcome. The committee discussed the matter and agreed that the tone was not appropriate given the member's connection with Brunton
