Currently: The Standing Rules, Sectional Tournament Policies, Table fees, Cost of lunches first paragraph currently reads, "Table fees are established as \$11.00 for sectional events and \$12.00 for Charity or ACBL Fund games. Non- or unpaid-ACBL members pay \$1.00 more. Beginners [0-5 masterpoints] who are registered in a current Easybridge! or Entry-level class may play free in Newcomer games."

Resolved: Rule shall read, "Table fees are established as \$11.00 for sectional events and \$12.00 for Charity or ACBL Fund games. Non- or unpaid-ACBL members pay \$1.00 more. Beginners [0-5 masterpoints] may play free in Newcomer games.

The cost of lunches between sessions shall be added to the morning entry fee or lunch tickets sold separately."

and N/I Workshops.

Currently: The Standing Rules, Salary and Fee Schedule, Class Fees has the following:

\$15.00 Per text for current editions of ACBL Series texts.

\$13.00 Per text for Easybridge texts.

Resolved: The Standing Rules, Salary and Fee Schedule, Class Fees for the above items will be changed to, "Charges for texts shall be charged back to students at cost plus shipping and handling rounding up to the nearest dollar."

Seconded and approved.

Currently: There is no rule regarding the transfer and storage of minutes.

problem.

Resolved: Electronic voting for officers shall be permitted.
