# **Board of Directors' Minutes**

Meeting held May 20, 2019 @ VCC

#### Call to Order:

The 5th meeting of the 2019 Board was called to order at 4:30 PM.

- All members but Annie were in attendance.
- Mike had to leave early so gave his report at beginning of meeting.

#### **Director & Office reports:**

**Mike** gave everyone a handout covering what he wanted to report. (See attachment #1) The first item mentioned was that VCC has a YTD deficit income of \$218.94. The other items listed are entered in Old and New Business of this report.

**Teri** passed our three handouts which are attached. She also had the new Village Card Club flyer printed, and she passed out copies for everyone to view. See attachment #2 to view the Communication Director's report to the Board for this meeting.

**Cathy** reported that no abnormal expenses made, just the usual.

**Linda** reported that we have a total of 525 paid members (446 Renewals plus 79 New members). 118 members from 2018 have not renewed.

#### Candace reported:

- Vicki Jennings, with Vicki Poecker assisting, are working on EasyBridge in the Fall. She and Debra Christian are working on the Mentor-Mentee games.
- Dates are needed regarding the Thursday night games so they can be sanctioned for points to be awarded.
- Play and learn games will not be awarded points.
- 12 mentees having less than 50 points are signing up with three others thinking about it. Mentors will be needed.

**Andy** reported that table count in 2018 was up 5.5% from the previous year; and that, through April of this year, it is up 1.6% from the same period in 2018.

#### **Alan** reported:

• We have three new directors in training: Peter Schaff; Ken Frankenberger; Nelson Ford

- Ginna Domm and Martha McAllister are co-chairing the Silver Lode Tournament (August 23-25) and will be meeting within the next 60 days.
- Annie did have a meeting with her committee and will give her report when present at next meeting.

#### **Old Business:**

#### Mike:

- New credit cards should be arriving in the next few days.
- New phone contract agreement with AT&T is progressing. The club would have "one" mobile phone hopefully with the same number as present. Locating the "pin" number required by Magic Jack to release the number is the holdup.
- On the last item regarding number of days for the club's sanctioned tournaments, there is a typo. He recommends fees for Special Games to increase by \$1.00 (not \$2.00). Instead of paying \$4.00, the fee would be \$5.00.

#### Alan:

He sent an email to Nancy Luehring and the POA Board members making a formal request to delay replacement of tables and chairs beyond 2019. (See attachment #6) Measurements for the carpet have been made and replacement should be scheduled soon.

#### Teri:

She noted that the website still needs some reports/files updated. For example: A motion passed by the 2017 VCC Board on April 10th of that year, stated that a limited game running concurrently with the open games be for players with 500 points or less. That motion was approved with an effective date of May 01, 2017. Records on the website were not updated to show this change. (Francine, along with Alan, will update the necessary files before the June Board meeting.)

#### **New Business:**

- Special game fee increase mentioned in Mike's handout and reported above under "Old Business". He is suggesting the fee be increased by \$1.00 for all Special Games which would bring fee to \$5.00 instead of \$4.00. (This motion was tabled for now.)
- Open House: Plans for an Open House to market the Card Club was suggested by Alan. Thursday evening and/or Saturday discussed as a good time for scheduling it. More planning to be made with all game liaisons involved.

- DBADD games to be performed starting June 1, 2019.
- Longest Day event: Planned for the 3rd Friday in June (6/21) with a silent auction. VCC umbrellas plus many items already obtained by Marcia Ballew.
- Tournament Policies:
  - \* Motion made by Teri that the VCC Spring Fling, Silver Lode, IN Sectional or IN Regional bridge tournaments will be three (3) day tournaments to be held on Friday through Sunday. Motion was seconded by Francine and passed by six to 1 votes. (See attachment #3)
  - \* Motion made by Teri regarding the Silver Lode Sectional Tournament to be a 0-750 NLM tournament beginning in 2020 was tabled until the September meeting. The motion was delayed until after this year's Silver Lode scheduled in August to see if necessary. (See attachment #4)
  - \* Game Strats for Open in conjuction with limited games: Teri had Russ Jones explain (see attachment #5). Players can play in any or all the limited games offered on the same day, but they can not also play in an Open game on that day.

#### **Future Business:**

Semi-Annual Meeting scheduled second Thursday in June (6/13).

Motion for VCC Board Meeting May 2019

#### I move:

Village Card Club Spring Fling, Silver Lode, IN Sectional or IN Regional bridge tournaments will be three day tournaments to be held on Friday through Sunday.

To be included in the Tournament Policies, which is part of the Standing Rules, effective immediately.

### Rational:

To further clarify the motion passed at the April Board Meeting 2019 ACBL approves three day tournaments for Open & IN Sectionals & IN Regionals.

It becomes very costly for local clubs to close. This would also impact their willingness to participate.

Past VCC tournament chairs have endorsed three day vs four day.

It cost more for four day: ACBL directors, room rent for playing area and housing for ACBL directors, lost revenue from our regular club games.

In the past, our three day table count is comparable to our four day.

It inconveniences our non-sanction games (Cribbage & Better Bridgers) on Wednesday evenings to set up for four day tournaments.

It puts a strain on our senior members to host a four day event.

RE: Casa de Carta / The Village Card Club

As the Board member overseeing Recreation for Hot Springs Village I submit this letter to you.

In the Fall 2018 The Village Card Club (VCC) successfully signed a lease renewal for a 10-year period. The 500+ members of VCC are very pleased the partnership with the Property Owners Association is continuing for another decade.

One term of the agreed lease reads "... Lessor will replace card tables, chairs and flooring in 2019." Now, five months into the lease the board of VCC suggests and requests the replacement of the tables and chairs be postponed indefinitely. There are two factors we wish you and the other Board members consider.

- 1. There are 42 tables and 168 chairs to be replaced. This is a considerable investment for the POA to undertake at a time when the cash might be better spent on other desirable undertakings.
- 2. The existing tables and chairs, currently owned by the VCC, are extremely functional and in excellent working order. Our members find the single-pedestal tables stable and the fabric padded chairs are very comfortable. The replacement of the furniture will create a hardship for the VCC in three ways.
  - a. Identifying and then transporting the existing furniture to an organization willing to receive them would be expensive undertaking to the VCC.
  - b. If no willing recipient is identified the remaining option is to dispose of these items. This drastic step is environmentally unsound and also financially wasteful.
  - c. Four-legged stackable tables are not as accessible for physically handicapped residents or guests compared to the single pedestal tables. This might provide members or guest in wheel chairs, for example, a reason not to participate in our programs.

Another factor we request be considered is POA utilization. The lease permits the POA to use Casa de Carta for four weekends per year and any other time the VCC "... is not making use of the (facility)..." Our long-range plan is to expand and diversify the card and game offerings by bringing new amenity experiences (for example organized Mahjong or Chess games) to Hot Springs Village residents and guests. As a consequence, the non-utilization – if we are successful at implementing our strategy – reduces opportunities for the POA use the space.

Please consider this a formal request to delay the replacement of tables and chairs beyond 2019.
