3. Matters arising from the minutes

70th Anniversary

For the club's 70th Anniversary event, Valdie had checked on the availability of venues in November and has provisionally booked the large hall at the Millennium Centre in Great Baddow for Friday 11th November.

It was suggested that the club should organise regular bi-monthly social events on a Friday starting in September, and the November anniversary event could be a special one in the sequence.

4. Playing Schedule Review

To assess the demand for changes to our playing schedule, two surveys had been sent out. The second survey was specifically to members who played regularly on Tuesday evenings, in light of the Lingwood club returning to face to face sessions at the same time. The responses were mixed, but a significant number desired no change. As a result of the surveys, no changes to our weekly playing schedule will be made at this time.
