TD COMMENTS - ALERTING AND ANNOUNCING

When to alert and when to announce? Announcements only apply on the first round of bidding. It is a player's duty to be transparent with all bids.

The basic rule on when to alert is if the bid is:

- A. Conventional
- B. Different from the expected norm in its shape/HCP etc. or
- C. It's forcing / non-forcing nature is not as expected (e.g. 1NT if it is forcing over 1 of a suit.)

New rules came into force on 1st September last year. The basic changes are:

- 1. Do NOT alert a 2NT opener. Only alert if it shows a specific feature or 5/5 in the minors as some do play.
- 2. Alert 2S bid by responder if it shows the minors or range enquiry. If the partnership plays full transfers over 1NT ie: 2S clubs or 2NT diamonds; then these must be announced as are the red suit transfer bids.
- 3. If a 1NT bid over a suit bid is forcing it must be alerted as the expected norm is that it is non-forcing.
- 4. A 2 level bid response over a one level suit bid by opener is expected to be forcing for one round. If it is not then it must be alerted. Also, if the 2 level bid is forcing to game and not just one round.
- 5. All bids that are not natural (conventional) must be alerted.

All bids above 3NT are not alertable except artificial bids above 3NT and ONLY on the first round of bidding.

More details can be obtained on the EBU website. There is an up-dated table on alerting / announcing displayed on the noticeboard at the club.

What do you do if you are not sure about alerting?

Blue Book 4A1 states that if a player is uncertain whether the regulations require an alert, but believes it will help the opponents then they should alert.

Players do come unstuck with conventional bids where partner has not alerted and they expect the bid to be natural. Be careful about using the Unauthorised Information from your partner's failure to alert. This scenario will be dealt with in future newsletters.
