Collins Bridge Club undertakes to collect and use your personal data in compliance with the General Data Protection Regulation (GDPR). Our legal basis for processing this data is our legitimate interest as a bridge club; we use the data for the administration of your membership, the communication of information and the organisation of events.

This information will be recorded in our membership database, which is stored in compliance with the GDPR. Our membership data is shared with CBAI, the governing body of the game of bridge in this country, and they will pass it to the South Munster Region of the CBAI, which looks after the clubs in our area. A limited amount of your information (Name, CBAI Number, Grade) will be listed in the online competition entry database, made available for Competition and Congress Organisers and Tournament Directors. This is to identify correctly players for competition entry and master point award purposes.

Your photograph may be retained for display on our website to record the winning of competition prizes or other noteworthy occasions.

Your data may be processed by Bridgewebs and Scorebridge, which act as Data Processors on behalf of Collins Bridge Club. They may only use it for the specific purposes for which they act as the Club's data processors, and they are not free to pass this on to other organisations that are not connected with Collins Bridge Club.

To enable control of entry to Collins Barracks, your personal data will be passed to the Military Authorities there. Your personal data is not passed on by us for use by any other third parties whether connected to bridge or not.
