President's Message

As many of you know, our Bridge Center building is one of only three in the nation wholly owned by the Unit membership. And our structure is an enduring one. Despite the recent damage and the length of time it is taking to repair it, our Bridge Center will emerge stronger and more resilient than ever.

But many Unit 360 members have asked, "Why is it taking so long to complete the repairs?" In a nutshell, the central problem has been obtaining insurance claim settlements. As originally envisioned, the entire process was going to be transparent to us. When first contacted, our insurance company assigned one of their "preferred contractors" to quickly complete the restoration and repairs. The contractor would bill our insurance company directly, with our insurance company then subrogating against the insurance company of the person liable for causing the damages.

However, shortly after completing the "emergency response" repairs, the "preferred contractor" withdrew from the project. That left us scrambling to find a local construction firm that could quickly step in and repair our facility. We finally located one and they quickly accomplished some repairs on the inside that enabled us to re-open and resume operations, having been closed for only about a week.

After that, our insurance company sent in an independent adjustor whose estimate of the scope of loss was unacceptable because it was incomplete and inaccurate. Then, our insurance company hired an independent architectural

Recently, our insurance company agreed to our contractor's price, which will result in the high quality that was lost rather than inadequate repairs at the cheapest possible price. Soon our building will be whole again. However, the insurance company has caused significant delays to the restoration.

I would be very happy to discuss this matter in more detail with anyone. We have learned valuable lessons about insurance coverages and claims after an accident like this. We all hope nothing like this ever happens again, but we need to learn from the mistakes we arguably made this time so we don't repeat them in the future IF we experience another significant loss.

Right now, let's all breathe a sigh of relief that this accident was not worse, and look confidently and optimistically forward to having our bridge home restored to its previous remarkable condition, and perhaps even better.




