## PRESIDENT'S MESSAGE

Hopefully, you have noticed the four trees recently planted at the north end of the parking lot (images before and after below). The trees are replacing the trees in that area which had died and were taken down over a year ago.

Thanks to Ed Texel, a past building manager, and Roger Williams, the current building manager, for finding the same variety of pinon trees to match the others which were planted years ago.

This variety of pinon tree requires watering in the first couple of years but are self-sustaining in our climate thereafter. Ed revived and modified the water system used when the other trees were originally planted in order to provide water to our new trees. Maintaining the border of trees was part of an original agreement with our neighbors.

The cost of the trees and of the planting was a little over \$2,000.00. Jim Black's family donated \$250.00 which was used to purchase one tree. # How to Criticize Your Partner (Part I) by Fran Pilch

Let us reflect together on this important topic of the best way to criticize your partner. Ok, here is the situation. I am South. This is my pathetic hand:

East opens 3 Diamonds. I pass. West also passes. My partner says Double. East passes. Now tell me honestly what would YOU have done? Can you guess what I did? It seemed perfectly logical to me. I passed. I knew almost instantly by the shocked look on my partner's face that I had made a mistake. A BIG mistake.

So let's take this opportunity to talk about what to do when your partner makes an incredibly stupid bridge blunder, otherwise known as an ISBB. Before we discuss your options for criticizing your partner, it is important to assess the context in which the ISBB has taken place. Ask yourself the following questions:

- 1) Am I married to my partner
- 2) Do I wish to stay married to my partner
- 3) Who is driving me home from the Bridge Center
- 4) Am I romantically involved with my partner, or do I ever hope to be? (note that this is different from question 1)
- 5) Do I want to play with this partner ever again
- 6) Does my partner cry easily
- 7) Is there any possibility that I myself might make an ISBB sometime in the near future
- 8) Is the lesson my partner will learn critically important and something he/she will remember FOREVER
- 9) Am I my partner's mentor (which gives me a little more leeway)
  - 10) Who is watching my reaction and will they judge me if I am a jerk. And do I care?
  - 11) Will anyone call the director on me?

In the case of the example above, I was greeted with a very disapproving glare and a stern lecture, repeated SEVERAL times, at increasingly higher decibels. "You cannot ever <u>EVER</u> pass my double.<sup>1</sup> I had a huge hand. The weaker your hand, the more important it is to bid SOMETHING." (We did indeed go down three, doubled, vulnerable). And, surprisingly, my partner didn't even

want to HEAR my rationale! Which I thought was SOLID! Needless to say, I did learn an important lesson. I THINK I will remember it. But FOREVER is a long long time.

In the interest of full disclosure, I have been pressured to confess that I myself once displayed truly abominable partner behavior. My partner, the stalwart Phyllis Dunn, bid 1 No Trump. I responded four hearts. My partner passed! She had two hearts and so did I. Down five, vulnerable. "Texas Transfer! <u>That was a Texas Transfer!</u>" I shouted rather nastily. In my defense, this incident occurred during my "obsessive" bridge phase.

Later, on reflection, I asked myself, "Who was that person who yelled at her partner." I didn't recognize myself and I was shocked at my own behavior. I sincerely apologized to Phyllis and told her it would never happen again. After I gave her two bottles of wine and outfitted the bathroom for a refugee family she was helping, she decided to forgive me. It has never happened again with Phyllis or any of my other partners. Nor will it!

# I have seen the light!

I will consult with one of our resident therapists to ascertain the optimal response and coping mechanisms when your partner passes your 2 Club opener. There might also be homework exercises to sharpen your skills. See you at the tables!


