What are Grand National Teams?

Grand National Teams is a grass roots team competition with the opportunity to become a National Champion competing with your peers.

This year offers an opportunity to compete in the District GNT Finals with no previous qualification required and at the masterpoint level as of August 6, 2019.

This is the year to field a team, play at the District level, win and go on to the National level to compete against the other District winners. If there are 8 teams or more competing in the Flight B & Flight C District Finals, the top two teams may go on.

Why play this year??

There are no travel expenses to a tournament – since tournaments have been canceled through July both the District and National competitions will be online – you can play at home.

District 17 waives the entry fee for the Flight C players (0-500 MPs, non-Life Master) and ACBL waives the entry for Flights A, B & C at the National level for the first two days of competition, D17 pays the entry fees for teams who progress beyond the first two days.

The D17 GNT Finals will be conducted on Bridge Base Online Wednesday, May 26th and Thursday, May 27th. The National Finals start Wednesday, July 14.

Because of the uncertainty of the situation, the Board of Directors decided to delay the December 2020 Board of Directors election until 2021. The Board members whose terms would have ended December 31, 2020 were asked to continue serving until May 11, 2021.

The plan is to have an election for Board of Directors in April of 2021. The Board members who are leaving the Board May 11, 2021, are Karen Campbell and John Ochsner and we are most grateful for the time and energy they gave. Two of the Board members, Linda Nicholos and Tom Riley, whose terms are ending, have decided to run for re-election. Since we cannot vote with paper ballots at the Bridge Center, as we have done in the past, we will be sending ballots to members that have email addresses to vote on-line using Survey Monkey. Members who don't have an email address, or who share an email address, or do not want to be contacted by email, will be mailed a paper ballot. The on-line and paper ballot will have voting instructions and will indicate the deadline of May 3rd for returning the ballots.
