3. Regional Information-Chris Caswell

There have been setbacks in discussions with the new management at the Quality Inn causing delays. The contract the regional committee is negotiating is for 5 days Thursday, May 19-23. The Quality Inn will hold 30 rooms for us at the rate of \$159 per night plus service fee. This rate is based on 2-night stay. They will remove the block 30 days before the tournament start date with no liability to us for unreserved rooms.

The cost of the playing area is \$9,000. There are cancellation fees: 25% penalty if we cancel 60 days before the tournament and 100% penalty if within 30 days. Anne, the treasurer presented some details based on a \$19 entry fee per session pointing out that there would need to be approximately 390 tables to breakeven.

In an email provided by Chris he added "In 2018 we had 938.5 total tables. However, the average per day was 134 tables vs the 78 average needed over a 5-day tournament, or requires 58% of 2018 count on a daily basis. I think this is in the approximate range we estimated would be required.

Note that Swiss day is only about 2/3 of the average daily count and would be one day of five instead of seven, but this may be offset by having slightly higher attendance on the fewer pairs days."

Most regionals being held now (mainly in the states) have 40% attendance. Since we are not meeting F2F it is hard to speculate how many members would be interested in attending a regional. Other expenses such as food and beverages may reach up to \$5000.

We have to make a decision before January 25.

We could hold a four-day regional but that would attract fewer players and bring in less income.

Suzanne moved that we not sign the contract with the Quality Inn but investigate options for holding a regional later in the year; seconded by Anne. Chris to contact the Quality Inn.

4. Treasurer's Reports – Anne

Anne informed us that the money from the ACBL has not been deposited into our bank account. The amount is around \$4552US giving us a net profit of \$934Can. In December we held 31 games and had 372 tables. In 2019 our table numbers were 269. We lost money in 2019. We had more costs – rent, cleaners, electricity etc. She has attached a graph with table counts over the last 3 years.

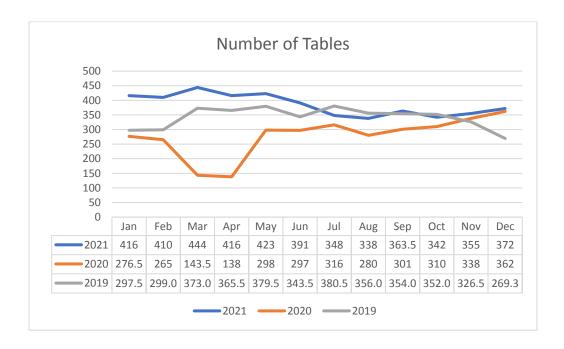
TREASURER'S REPORT

for the month of December 2021

In December we played 31 games, with 372 tables and a game revenue of \$4,440 CDN. The deposit exchange rate to Canadian dollars was 1.24. The net profit for the month was \$822.

In this same month last year, Dec 2020, we had 362 tables.

The following graph compares the number of tables that we played in each month over the last three years. In 2019 all of our games were face to face, but since April 2020 all of our games have been online. You can see the dip in the number of tables in March and April 2020 when the pandemic put us in lockdown and we transitioned to playing online.



ACBL fees: this month we paid \$116 for the online club sanction renewal.

Bridge lessons: \$180 was paid to the Seniors Centre for rental of classroom space.

Club Manager Report

January, 2022

We are starting this new year off on a strong foot. The virtual game attendance is good and we have lots of extra games scheduled. The ACBL has agreed to continue with silver and gold point games into April.

Carryover:

Jerry MacDonald's family is hoping to hold a Celebration of Life for Jerry at our club in the spring or summer. Peter Johannsson has agreed to cover the cost. Is this okay with the Board?

Scheduled events:

- Silver Linings Jan17-23: Extra game Saturday the 22 at 6:30. (2X Silver points)
- Extra Game February 5 at 12:30: Awards event and Year in Review. Elaine created the newsletter.
- Valentine's Weekend: Extra game on Saturday, February 12 at 6:30 (2X points/half red)
- Education Week: 2X black points, extra game February 27 at 6:30.

New Items:

- 1. We presently get information monthly from the Common Game, such as new ranks at no cost. For \$100 per annum we could get a premium package which includes a monthly roster of all players in our games with up to date masterpoint holdings and a program that would let the directors know when a player who has signed in has been removed from the player list at game time. When we start F2F we could also use hands they provide. I would like to purchase this.
- 2. Our Club Members Master list has been updated and we start this year off with 274 members. Last year we had 224 members. Our list is growing because of new members being recruited thanks to Tammy and Suzanne and also to a few players from away who regularly play in our virtual games and have been invited to join our club.
- 3. Our Sharing Partnership Information list is ready for distribution with 124 players agreeing to share their information.
- 4. I have not updated our Not-for -Profit information with the Ontario government. Anne has sent me the website so I hope this will be fixed up this month. There have been issues with our address.

1. As of Monday Jan 17, the new I/N mentor program for 2022 has 12 Mentors and 12 Mentees, plus 3 spares, a Director, and 3 planned games.

Mon Jan 24, Mon Feb 21, and Mon Mar 21

Games will begin with a 15 min Chalk Talk at 6:30 on Zoom for all participants given by Tammy Gauvin. Then all players will log onto BBO, Mentees invite Mentors, game will start at 6:50pm. We plan to play 16 boards, with a 10 min chat break after round 4. This is subject to Director suggestions.

It is expected that the Mentors will connect with their Mentees to make sure all steps are understood and practiced prior to the first game ie. BBO\$ in the bank! All participants are members of KDBC and Mentees will be strongly encouraged to join ACBL using the link on our website asap.

As Mentors will have the same Mentor for the 3 months (except where the Mentor is not available), it is hoped that Casual/Teaching Tables will be set up among small groups of participants for practice between the games.

An email will go out to all participants with matches of Mentor/Mentee and all contact info tomorrow.

In setting this up a total of 36 possible Mentors/Spares were called and 23 possible Mentees have been contacted.

I see this as a beginning and there is lots of room for this I/N Mentor Program to grow. The program will take us to April when we may have a better idea of F2F play and how that will impact our plans going forward.

A possible offshoot is more players for our Tues 1:05 game!! We can only hope!! I welcome your suggestions or comments!
