1. APOLOGIES FOR ABSENCE

4. FINANCE

Given the current climate, the EBL and WBF are both running events next year.. Ian gave a run down on the Board's position concerning the plan to go forward. The Board may struggle to promise financial support for teams in the coming years.

(PAUL BARDEN ARRIVED)

The Juniors would still take precedence for funding, as the Board determined that the Juniors should be the last to have funding withdrawn. It is unlikely to be feasible to fund two sets of events for the following year, the European Championships and the World Championship series.

The Selection Committee suggested presenting the previous year budget as drafts for this year in order to help acquire sponsorship.

ACTION: PB and CB to draft a document to provide for sponsors.

5. PREMIER LEAGUE DATES

The Selection Committee endeavoured to set strong provisional dates for future years with reserve dates and then creating a cycle. The dates would be set by a subgroup (MB, Nick Doe, GF).

The Young Chelsea has contacted the Committee to request bookings for the 2020 Premier League. The SC was not in a position to confirm whether the PL would run in 2020.

However, if it did run then the YC would be used. It was discussed if divisions should be played in different venues for financial sense. Spondon was also considered as an additional venue.

ACTION: GF to reply to the YC enquiry

6. JUNIOR LIAISON OFFICER JOB DESCRIPTION

The Selection Committee has determined the need for a Junior Liaison Officer, and approved the circulated document without amendment.

ACTION: CB to send document to PB and AM to send to squad leaders..

The Junior age categories set by WBF allow for those eligible this year to play in the following year, and the SC has agreed to stay with this.

2 The WBF has announced that the 2020 World Bridge Games have been cancelled. The next World Bridge Games will take place in 2022. The SC resolved to offer the winners of the 2020 World Bridge Games Open Trial an International representative event within the next 12-18 months if that is feasible.
