The SC determined to allow for an 18 month year this year to begin a seasonal proposal to consider when a year should end. The SC resolved to ask the Squad Leaders their opinions on different number of awards and what categories they should be awarded for, and when a "season" should end.

The Committee agreed on a paper to the Board on which events were covered by the new 10 year ban on representing England should a player be found guilty of cheating.

The Committee received an invitation to send a junior team to an Italian online event. The Committee selected:

The Committee thanked all the NPCs for their reports.

The Lady Milne team was determined directly from the trial. The question of NPC raised whether the SC should always consult the team or assign an NPC without consultation. The SC determined to make it on a case by case basis. It was suggested to ask for opinions in the invitation to any team, which may be disregarded at the discretion of the SC.

A list of candidates would be discussed by email for the LM NPC.

#### **4. RESPONSE FROM THE COMMITTEE TO THE BOARD POSITION ON THE 2021 EUROPEAN CHAMPIONSHIPS AND 2021 WORLD CHAMPIONSHIPS**

The SC determined that it was for the players to respond to the board as the SC's role was to select and that was unchanged. It was also considered that this stance could undermine future trials. It was suggested to send the Board a letter with considerations for how there may be knock on effects.

#### **5. STRATEGY FOR INTERNATIONALS AND FUNDING PRIORITIES**

Funding internationals helps promote juniors for motivation and encouragement.

Funding based on strength for results was also considered alongside the accessibility to each event.

Some members of the Committee felt that funding the women's and open teams would increase their strength whilst the same would not be true for mixed and senior.

It was considered whether it would be helpful for the teams to play in a game with members to help the members see where their money was being spent.

The following priorities were roughly agreed

Priority 1: Entry and uniform

Priority 2: Juniors

Priority 3: Open

It was considered to ask the board what their opinion was on the funding priorities.

CoC were considered to add a funding cap.

#### **6. RESPONSE TO THE LETTER IN ENGLISH BRIDGE CONCERNING DEFUNDING INTERNATIONALS**

#### **7. REPORT FROM JUNIOR LIAISON OFFICER (CR)**

Well done to the Junior Camrose team in regaining the trophy and to the Peggy Bayer team in retaining it. Note though the standard was not as high as it will be in the forthcoming World Championships. Strategies that were successful in JC/PB may not be so successful in higher standard events.

CR is doing different work with different squads.

- First U16 Play with the Experts was very popular and successful. Plan to run these events every 2-3 months.
- U26W have mentors appointed by Sally who coach their pairs on topics each week. Claire, Ollie Burgess and Paul Barden are running regular teams matches with Zoom to talk through the boards. Two of these have already happened, another in a couple of weeks' time.
- U21s and U26s - still considering what age appropriate development could be done here. Considering masterclasses/seminars on different topics by a series of experts.

CR is starting to build picture of the juniors we have and the depth of talent. However, squad lists are not up to date and squad leaders may in fact be missing some players in their age categories who are quite capable. CR needs to liaise with CB and squad leaders to get more contracts signed and lists updated.

A popular U26 duplicate is happening on Fridays at Young Chelsea online. Turn out is great and many of the players CR has not heard of. They seem to be the 'university crowds', a whole bracket of 20-23 year old players who we haven't got at all on our radar and are in danger of being missed. Need to think how to assess and bring in more of these players to our squad system and one day maybe representing England. Looking through the boards and results, many look like they have a good idea about the game and would be at home in our junior squads.

The Committee needs to consider selection of an U26 team for Worlds. Unlikely that squad leader will be in place enough in time to be able to have an informed view on selection. Neither do we as a committee have a proper view on who should be selected. CR suggests some form of trial similar to that which has taken place in the past and in line with the way we have moved for adult events to choose an U26 team. PB ran a successful trial for this squad in the past.

Action: PB to put together some ideas for what a trial for the U26 team might look like.

**8. JUNIOR SQUAD SYSTEM REVIEW**

In the light of the need for a new U26 junior squad leader, the Committee took the opportunity to discuss whether the current squad structure was still the most appropriate. Several options for restructuring had been proposed by members of the Committee. It was determined that these options had merits and it was decided to discuss the main possibilities with the squad leaders.

Action: CR to discuss restructuring the squad system with the remaining squad leaders.
