I have a senior executive role at a major corporate with global team of 100. This gives me practice with managing a very wide range of stakeholders and people of all ages, backgrounds, nationalities and experiences.

I also have a lot of experience writing board papers, presenting at industry events and explaining complex regulatory and investment matters to non-experts which is good practice for trying to explain the Laws of Bridge to players.

As my background is as a mathematician and my current role is in corporate treasury I have a good understanding of statistics and probability, which is important when assessing accusations of potentially unethical behaviour.

I am a Director of multiple companies and sit on two Bank of England committees, giving me experience of corporate governance.

3 Past and present activity as a bridge player or Tournament director (at any level)

Director: Qualified EBU County TD and EBU referee. I frequently chair appeals committees or act as referee and I am active on online forums discussing & advising on rulings. I am often consulted on rulings.

I write regularly for English Bridge as well as taking part in email and social media bridge conversations including the EBU TD Forum. I am also part of the Tournament Panel.

Player: I have won the Gold Cup, the English Premier League and the Camrose team; I played for the English Open Team in 2016 and the English Mixed Team in 2019. I still play occasionally at local clubs as well as in club and county events and my father is active in his club so I have a good idea of the concerns of players of all standards. In the past few years I have played in tournaments in the USA, South Africa, Norway, Sweden, Australia, France and Japan giving me a worthwhile perspective on how other countries run bridge events.

4 If you were on the L&EC during the previous year, what did you achieve?

I write many documents for the L&E. I am the editor of the Blue Book and actively seek out, and act on, comments on possible inconsistencies or lack of clarity. I also contribute to the White Book and advise on club and county regulations when asked.

I am one of two members of the L&E who screen every appeal & 'report of hand' form filed from EBU events to agree on which should be discussed at committee.

I regularly respond to email and internet queries on laws, regulation, rulings and appeals (as well as on bridge!)

As Vice Chairman of the L&E, I consider all relevant letters and submissions to the EBU or the Committee in consultation with the Chairman and the secretary, and contribute to the drafting of replies.

I have previously written articles for the EBU website, 'Appeals focus' & the EBU magazine on laws & ethics (in addition to articles I have written as an player).

I never claim any expenses for attending L&E meetings.

5 What would you personally hope to achieve during your tenure on the L&EC?

I will continue to work towards

- Simplification & standardisation of regulations (sadly I have no control over the Laws)
- Improving the consistency of rulings & appeals by providing more detailed guidance on difficult areas
- Encouraging TDs to not to penalise players for not understanding or being confused by explanations they are given
