- Election of EBU Shareholder Delegates After discussion around the situation of having delegates who are current LCBA committee members, Dean Benton and Dave Pollard were appointed.

- **5. Appointment of LCBA Webmaster and Master points secretary:** it was agreed that Richard Smith and Neil Beasley respectively should continue with the roles.
- **6. AOB:** Dean raised the possibility of running refresher courses for club directors following the issue of the new laws book by the EBU. Following discussion, it was agreed that the LCBA would pay for Steve Wright, John Wilcox, Robert Northage and Andrew Billson to attend the 'Changes to the Law' course to be run by Nottinghamshire CBA in July. The LCBA TDs then plan to organise 1) Training on any other County TDs 2) Revising and reissuing the guidance to TDs that the LCBA issued after the 2007 Law changes 3) Training of club TDs. It was agreed that the LCBA will cover any expenses incurred.
