Financial Statement 2021/22

Muriel reviewed the Financial Statement and noted that we are in a very good position having a bank balance of \$7288.77, and showing a profit of \$854.00. Budget

Muriel reviewed the budget. Based on the shortened year in 2021 she doubled our needs for 2022. While we had educational activities there was no impact on the budget. We are maintaining game fees at \$5.00 and memberships at \$20.00. In response from a question from the floor she advised that current memberships are effective until our next renewal in September 23.

Club Manager Update

Claude noted Muriel's contributions to the Club as Chair and Treasurer and thank her on behalf of the members.

In the beginning it looked as if Friday games may not be sustainable but we agreed to monitor them over the summer and make a decision about continuing them in the fall. He was happy to report that they are sustainable.

He reported that we need more directors. He introduced the current directors, Chandi Jayawardena, Violi Whitmee, and Heather Beckman and thanked them for their service. Muriel and Claude continue to serve as back-ups.

Claude thanked Vern Chant for his contributions in making up the game boards which helps the directors on game days. He also thanked Verne for his contributions in managing the bar and serving on same.
