Aileen Timoney noted that Cavan County Council and the North Eastern Region had each provided €500 in sponsorship for the Senior Congress, not yet noted in the accounts. She was also hopeful of persuading Cavan County Council to provide a little more.

Council adopted the report with thanks to the Treasurer on the proposal of Nuala Mooney, seconded by Aileen Timoney.

## 6. International Committee report

John Murchan had circulated a report to delegates in advance of the meeting, The report is attached to these minutes.

The Open Team finished 6<sup>th</sup> in Madeira, the Ladies Team 9<sup>th</sup>. The Senior and Mixed teams were not successful. The Open Team would qualify for the Bermuda Bowl, and the Ladies Team are first reserves for the Venice Cup.

As a consequence of the Open Team's success in Madeira, we had received an invitation to send our national champions to the Champion's Cup in November. The invitation would be extended to the winners of the Egan Trophy, and in subsequent years the winners of the previous year's Egan would be invited.

The report was adopted on the proposal of Michael McFaul, seconded by Gordon Lessells.

## 7. IYBC report

Martin Brady had received a report from Niamh Gornally and circulated it to delegates in advance of the meeting, The report is attached to these minutes.

The Committee's successes during the year were noted, and the link it had established with Michael Byrne and the EBU coaching programmes was particularly welcomed. The Committee was clearly in need of further administrative support from the IBU, and this would be considered when electing the new committee later in the meeting.

Brid Kemple noted that the Regent League would welcome an entry from juniors in the Area Master division. This would be communicated to the committee. She also noted that Dublin South donated €500 to junior bridge every year.

The report was adopted on the proposal of John Murchan, seconded by Heather Hill.

## 8. Competitions report

Martin Brady had circulated a report to delegates in advance of the meeting, The report is attached to these minutes. The following points were noted about competitions that had taken place since the last Council meeting:

- **Moylan Trophy** Lots of complaints had been received about the table money charge (€50). This was acknowledged, though the proportion of money paid back through the prize fund (40%) had remained the same. The competition had made a profit of €895.
- **Senior Congress** Thanks were offered to Aileen for the continued organisation of this event at the Cavan Crystal Hotel. The event, held very shortly after the return of face-to-face bridge, had resulted in a loss of €1,226.
- **Club Pairs** This event had been held online (on BBO, on the recommendation of Chief National TD Fearghal O'Boyle), with a strong entry and a final profit of €2109.
- **Egan Trophy** Only 8 teams were able to attend, and the regular hotel (La Mon) was temporarily unavailable. The event ran at a deficit of €1,007. Despite the deficit, the event was justifiable both in its role in providing a qualifier for the Champions Cup, and as a final preparation for players attending the European Championships in Madeira.
- **2022/23 competitions** Venues and dates were fixed for all events except the Interprovincials, for which the Cavan Crystal was not available. We would try to organise this event in Templeogue instead, and return to the Cavan Crystal in 2023-24. It was agreed to continue holding the Club Pairs online.

Brid Kemple asked if the Burke and O'Connor would continue to be organised as Open competitions. Martin Brady confirmed this: teams would enter directly, rather than qualifying, but teams would still be required to be eligible to represent a particular county.

On the proposal of Pat O'Mahony, seconded by Brian Mullan, it was agreed that the winners of the Club Pairs Open Section should receive an invitation to the following season's Moylan Trophy.

## 9. President's Address

The President thanked all officers and Council members for their hard work during another COVID-disrupted year, and hoped for a significant increase in face to face bridge and the return of club players during the coming season. He extended particular thanks to Peter O'Meara for deputising on several occasions during his period of illness. He congratulated the Ladies Team and the Open Team on their tremendous results in Madeira and thanked Mark Moran in particular for all he had done for Irish bridge.

Grainne Barton reported that an article was in train for the next Newsletter, and her team would be willing to meet players on the ground. Brian Mullan noted that players who represented Ireland abroad were still out of pocket for the experience, and this should be made clear also.

Brid Kemple requested that the IBU send a report to the September, March and May meetings of CBAI Governing Council, updating them on all relevant activities. This would be done.

Paul Porteous reported that although efforts had been made to bring a championship to Belfast in 2023, the event had gone to Strasbourg, in large part because Strasbourg was on the European mainland.

Gordon Lessells requested that the following be noted for congratulations:


- Paul Porteous, who had topped the vote for re-election to the EBL committee
- Grainne Barton's Open team for their 6<sup>th</sup> place finish in the Open category in Madeira. The President particularly thanked Mark Moran for all he had done for Irish bridge.
- Paul Porteous's Ladies team, an all-Ireland team (with NIBU and CBAI representation), for its historic best performance in Madeira.
