3. Reports:

a. Treasurer: Cathy Strawn reported that the Bookkeeper's analysis was emailed to the board members. September was an average month for table fees and donations. Donation was made to Omand Church of \$212. There were one-time extra charges of \$402 for AED Battery and \$445 bank charge re fraud. Basic profit of \$181.

- i. Contact has been made with the TD bank to get 4 signees for future cheques. Signees will be Cathy Strawn, Jim Lamorie, Andy Aitchison and Frank Turbach (2 of 4 to sign).
- **ii.** The following incident was mentioned at September's meeting but since it had not been resolved at that time reporting was left until this meeting. It has now been resolved.

Our club was recently the victim of financial fraud in the approximate amount of \$8000. The bank was informed immediately and the police were notified. Through the bank we were able to recover the full amount less a service fee of about \$445 (US). Restitution will be made to the club for these fees. As a result of this incident the club will now do banking by cheques with double signatures. E-transfers will no longer be used. The club will never ask members to pay on its behalf or request banking information.

- **iii.** Moved by Cathy Strawn, seconded by Jim Lamorie that we invest \$10,000 in a GIC that provides the best rate for an appropriate time period. Carried.
- Club Director: Andy Aitchison reported that the club had received a caution from ACBL about paying game fees on time or risking losing ability to get points.
 Duly noted.

5. Special Games and Closures for November / December.

- **a.** Tuesday November 11th will start at 1:30pm to allow members to attend Remembrance Services.
- **b.** Club will be closed from December 20 to January 4th inclusive for the Christmas Season.

- **b.** AED training session was held October 22nd with 12 people from the club and church attending. Lynne Allen from North Bay Fire Department donated her time to hold the session. - **c.** Report on the North Bay Sectional slated for April 10-12th, 2026. Notice has been approved to go on the ACBL website. Osprey Golf Club has been booked for that time slot, Norm Mallette from Sudbury has been contacted to be general director.

September was a "fair" month from a financial perspective.

Table revenue was about average for the month at \$3188. Total revenue, including donations, ticket sales, and interest (as well as Table Revenue) was \$4955.

Expenses were above average at almost \$5300. This was because of 2 "extraordinary" expenses and one "regular but not monthly" expense

- 1) \$402 for a battery for the defibrillator (Equipment Account)
- 2) a \$445 charge by the banks for negating the "fraudulent transaction" (Miscellaneous Account)

Note that Cathy Straum has committed to re-imbursing the club for this expense by forgoing all or part of her salary for the next few months.

3) a donation of \$312 was made to Omond Church (Miscellaneous Account)

The Club had a loss/profit of \$181. The Club still has a significant Bank Balance of \$21,221, as well as GlC's of almost \$32,000.
