## • Chairman's report

As we emerge from the pandemic, the Club (and bridge itself) is in a different place from two years ago and we are still to discover exactly what that place is. In many ways, for the Club, it is a good place. Teaching has started; there are six drives or teaching sessions each week at the club and two on BBO; 118 people have played face-to-face so far this year and 75 on BBO on Tuesdays.

# • Treasurer's report including and receive annual accounts and membership report

# • Appoint independent accounts examiner

It was agreed that Dave Beaumont be asked once again to act as the independent accounts examiner and a letter of appreciation be sent to him for his previous service in this role.

With the introduction of a cashless system the trustees decided it was impractical to charge visitors a table fee. Instead, visitors play free for three sessions and are then required to become members. This costs them less than the previous arrangement. To accommodate them a this, a change to Rule 2 of the Club's rules is proposed as follows:

## **MOTION:**

Visitors shall pay a table fee fixed by the trustees and will be allowed to attend the Club on three occasions in any calendar year: provided that no person shall be a visitor into the club who shall have been expelled from membership or whose conduct or presence in the Club House shall be considered by the trustees objectionable or prejudicial to the interests of the club.

Motion Proposed by David Dunford, Seconded by Mark Goddard, universally accepted by the meeting.
