- 1. The minutes of the Board meeting held on 05/12-Sep-2019 were agreed to be accurate.

2. Updates on ongoing action items from meeting held 05-Sep-2019

- Ladies bathroom Fran and Rahul met with the Swilers' management in October who indicated that there was no money to fix the problems with the bathroom as there had been significant expenses associated with the tournament held in the summer. We believe that this will provide the biggest benefit to the most members.
