Declarer cashes two top diamonds from hand:
Trick 2: Declarer leads A : A-8-4-3
Trick 3: Declarer leads K $\$$ : K-7-5-6

At Trick 4, declarer leads 2 from hand, and you have to decide whether to ruff or not.

Q4: If you do ruff, then with which trump, and how do you proceed? If you choose to discard, then what do you discard and what is your general plan?

Partner leads a small spade，won by your Ace－Trick 1：5：5－4－A－2

Q2：What continuations do you consider at this point？
Suppose you choose the Jゅ，Trick 2 going：Jゅ：Jゅ－Kゅ－6－8ゅ

Q3：What is the remaining spade position？

Q4：How many minor suit cards does declarer have at most？

At Trick 3，partner continues with the 10\＄，declarer playing the King from dummy which you win－Trick 3：partner leads 10\＄：10－K－A－3

Q5：What is your defensive plan from here？

Q1: Would you have opened the bidding with the South hand?

Q2: Now that you see the dummy, how many points does partner hold?

Partner kicks off with the 109, dummy playing the Jack and you the King, declarer playing low.

Trick 1: partner leads 10: 10-J-K-3

Q3: What do you know about the spade position?
You continue with a low spade, declarer winning - Trick 2 you lead 2 : 2-A-7-6
Declarer cashes the club King, then tries a small club to dummy's 10 which you win.

Trick 3: Declarer leads K\$: K-6-2-7
Trick 4: Declarer leads 8\$: 8-4-10-J

Q4: What is the remaining club position?

You persist with spades at Trick 5: you lead 5 : 5 - Q - 8 - 4

Q5: What is the remaining spade position?

Now declarer plays a diamond to the Queen in dummy dropping your singleton Jack: Trick 6 - declarer leads 4 *: 4-2-Q-J

Declarer cashes the A on the table: Trick 7 - dummy leads A\$: A\$-5-2 At Trick 8, declarer leads a low heart from table - Trick 8: dummy leads 7 •: 7?

Q6: How do you defend from here?
