3. Minutes of the AGM held on 12 September 2023.

5. President's Address.

Irene Norman has done a wonderful job with the trophies and the Honours boards which will be updated shortly.

Special thanks to Sue, Bill and Lou our excellent teaching staff without whom we would not have the new members they encourage.

Thak you to Wanda and Lou for all their hard work they have done. It was difficult for them both as their predecessors were no longer available for guidance, but they had the total support of the Committee and I'm sure you'll agree have done a marvellous job.

Finally, I want to say a particular thank you to Dave Couling who has been so supportive and helpful taking over my role in January for three months and did such a good job nobody noticed my absence. Thank you Dave.

Things are settling down now and hopefully next year will be a little bit easier, membership is stable, and attendances are slightly up, with the afternoon sessions by far the most popular.

We have introduced a Friday Masterpoint session once a month, which is proving popular but unfortunately at the expense of the evening session, so we are not proposing to extend any more Master point sessions in the near future.

There are plans in the near future for refurbishing the kitchen and Lou is planning more Wednesday workshops and any so lots to look forward to.

6. Secretary's Report.

The membership at the yearend stands at 136, including two Life Members.

Sadly, we have lost four of our members, Brenda Goodacre, such a stalwart of our Club over so many years, Lynn Drury, Dorothy Wells and John Walker so very recently. Our heartfelt condolences go their families.

After a controversial year, the current year did not start auspiciously for the new Committee. Some elected committee members resigned and so I have found myself as your Secretary for this year.

It has been a bit of a baptism of fire.

The main item this year has been that we have now had the work on the roof finally completed. Val and Mike will be explaining matters more fully.

We have had a major clear-out of all the extraneous detritus, built up over many years, throughout this year. The club certainly looks a lot clearer than it did.

The existing cleaner retired and her deputy has taken over.

PAT has been done, free of charge, by two of our members Neil Strutt and Rennie Bennington.

We have produced policies for things like H & S, Safeguarding etc.

Tuesday PM sessions seem to go from strength to strength. Friday PM sessions are very well attended. We have averaged just, just under 10 tables on Tuesdays and nearly 7.5 tables on Fridays.

The downside to the increase on Friday afternoons has been the Friday evening sessions are not as well attended. However, the WhatsApp site has proved invaluable in getting a session organised. We thank those who are taking the lead to organise the evening session.

7. Treasure's Report.

Mike went through the accounts for the year ending 30 June 2024.

He started with the Income/Expenditure side.

The Bar is running OK. There was a slight increase in interest rates. There was a surplus from the Christmas party of £150.00.

Expenses remain stable but will increase as our energy contract expires in the coming year.

The Bridgemates were serviced during the year.

The surplus for the year is £3534.

Looking at the Balance sheet the total cost of the roof was £63,000. We managed to get two grants of £25,000. A part of the one of the grants was withheld.

Only part of the total was paid before the June yearend. The balance has been paid since.

Mike explained how he had accounted this.

He expressed his thanks to Keith Stewart for checking the accounts so promptly in view of the shorter time.

Mike asked if there were any questions and there were none.

Bill Keast proposed a vote of thanks to the Treasurer. All agreed.

The accounts were proposed by Bill Keast, seconded by Pat Donaldson, and accepted unanimously.

Bob Atkin added that he thought the Committee had done a great job this year.

8. Motions.

The President explained the reason for this motion from the Committee. The motion was to amend Section 12.7 to remove the limit on life members.

It was passed with one dissension.

9. Trustee.

The appointment of a new trustee has to be done at an AGM or EGM.

The was only one name put forward, Neil Strutt, and his appointment was accepted unanimously.

10. Election of Officers and Committee.

Wanda explained that election needed to take place the position of Vice President because there were two candidates. As one of the candidates had also been nominated for committee membership making eight candidates when only seven were required a vote was required for the Committee too. It would however depend on the outcome of the VP vote.

Bill Keast and Bill Brocklesby agreed to be scrutineers.

Following the vote Lawrie Chapman was duly elected as Vice President.
