Staff are provided with face masks and worn front of house.</p> <p>The venue has multiple hand sanitising units throughout the building and at the entrances.</p> <p>Staff have cleaning schedules to ensure touch points are cleaned on a regular basis.</p> <p>Social distancing must be maintained in the lobby and reception area.</p> <p>The venue numbers have been reduced by 50%. The large result screen will be situated in the bridge hall.</p> <p>Comply with SCBA protocol</p>	<p>This will depend upon the national covid measures at the start of October 2021.</p> <p>The organisers will request that all entrants have had both covid jabs.</p> <p>All entrants must declare that they are covid free and free of cold or flu like symptoms.</p> <p>There will be no temperature checks.                      Screens are not required.</p> <p>Face masks are optional in the playing areas and as required by the venue protocol.</p> <p>Players are allowed to consume their own food in the playing areas . Food is not available except through established caterers not part of the congress.</p>	<p>Organisers, venue staff and the bridge players.</p> <p style="text-align: right;">Bridge players</p>	<p>Before the congress and on the day.</p>	

<p>Covid 19 risk is low /moderate</p>		<p>The Director is responsible for Setting up the sessions and implementing the control measures.</p> <p>Before each session the Director must ensure that bridge equipment, boards and bidding boxes are cleaned with a sanitiser.
