

1. Each applicant must be proposed and seconded by two club members who know the applicant personally.
2. The applicant must pass the completed application form to the Membership Secretary (see above left) for display on the Club's notice board for at least two weeks prior to committee consideration (please leave the completed form on the table just inside the front door, marked "For The Attention Of The Membership Secretary" or pin it on the notice board just above the table or e-mail a scanned version (page 1 only) to a\_luckin@sky.com). The committee will then consider the application; accepting or rejecting it
3. Each bridge applicant is required to pay non-refundable visitors' fees (currently £3.00 per session for Bridge (£3.50 for Monday afternoons) for up to 6 weeks (snooker fees are paid by meter which takes £1 and 20p coins)
4. Once an application is approved by the Club Committee, the appropriate subscription is then payable (£45 for a full year (October to September): applied pro rata)

## A. BRIDGE AND SNOOKER MEMBERS

The Bognor Club undertakes to collect and use your personal data in compliance with the General Data Protection Regulation (GDPR). ## B. BRIDGE MEMBERS ONLY

### i. General

Our membership data is shared with the English Bridge Union – the governing body of the game of duplicate bridge (please visit [www.ebu.co.uk/gdpr](http://www.ebu.co.uk/gdpr) to see what data the EBU holds about you, how you can limit its use and how you can ask for inaccuracies in data to be corrected). The EBU will pass it on to your “county of allegiance” which is usually the club’s primary county bridge association. A limited amount of your information (name, EBU number, county, post town) will be listed in the EBU’s database made available for use by scoring program providers and users. This is to allow the correct identification of players for scoring purposes. Information relating to your National Grading Scheme (NGS) grade and master point rank, together with your county of affiliation, will be generally available from the EBU website unless you have chosen for it to be private. You can do this by logging on to My EBU -> Account -> My Details at [www.ebu.co.uk/members](http://www.ebu.co.uk/members).

Your data may be processed by Bridgewebs; acting as a Data Processors on our behalf. Bridgewebs may only use it for the specific purposes for which it acts as our data processors and they are not free to pass this on to other organisations that are not connected with The Bognor Club.

### ii. EBU Membership

By becoming a bridge member of The Bognor Club, you will automatically become a member of the EBU. The EBU will receive your contact details and will send you a welcome pack **UNLESS YOU CHOOSE TO BECOME AN ANONYMOUS MEMBER.** If you choose to become an anonymous member, this means the EBU will have a pseudonym on your record with your EBU number.
