#### Interstate Bridge Championship Selection Trials Sunday, 22nd June 2025, TNBA Office - SDAT, Periamet, Chennai

The Inter State Championship will be held from 1st August to 5th August 2025 at Mysore, Karnataka. It consists of Team and Pairs events. Tamil Nadu is eligible to send 2 teams and 6 pairs.

TNBA EC has decided to select a maximum of 2 teams. The selected players will play in teams. If qualified they will play in teams finals, else in pairs. So, the selected players must play both Team and/or Pair Events.

#### **Selection Procedure**

- 1.Only TNBA members who have paid membership fee and master point fee up to the last date are eligible to apply. Fees must have been paid for current and earlier years. Players must have a BFI master point number.
- 2.Entries will be called for on the basis of Team Entry ONLY
- 3.Selection will be a 1 days event (Subject to the number of entries, it might be extended to the next day)
- 4.Selection will be on an all-play all round-robin basis. TNBA EC reserves the right to change the format based on the number of entries and convenience of organisation.
- 5.Date of inter-state selection event: Sunday, 22nd June 2025 6.Entries will open on 10th June 2025 Last Date for Entries: 17th June 2025
- 7.Venue for the selection trials will be TNBA, SDAT, Periamet, Chennai 8.Entry Fee Rs.4,000 per team.

#### Reimbursement for selected players representing TN

- a. Each player selected will be reimbursed as below for expenses incurred to attend the Inter State at Mysore.
- For travel 2AC Train fare on actuals
- Rs.2000/- per day of play for accommodation, meals and other expenses. No advance will be given.
- b.Participants will need to make their own arrangements for travel & lodging.
- C.All participants will need to submit receipts for all expenses to the Treasurer, TNBA within 10 days of tournament completion.

Note:
i.If one of the players selected is not able to participate due to
unforeseen circumstances, then the team may choose a replacement,
with the prior approval of the TNBA Executive committee. Co-opted
players need not have participated in the trials.

ii.BFI & WBF Conditions of contest will apply wherever this document does not provide clarity

iii.The decision of TNBA EC will be final & binding in all respects and on all participants
