#### 4. Election of Directors

### 5. Treasurer's Report

## 6. Membership Report

While membership fluctuates throughout the year, our unit membership has increased 7% over last December, going from 587 members then to 628 members now (a net of 41 new members).

# 7. By-Laws Revision

The Unit 191 Board has proposed a revision in the unit's By-Laws to codify better the unit's election process. The revision is precipitated somewhat by the cancellation of last year's annual meeting due to inclement weather and the resulting status of the unit elections. The objectives of the revisions are three-fold:

- to define the composition of the Nomination Committee to include both members of the Unit Board of Directors and unit members who are not Board Directors;
- (ii) to provide a procedure for Unit members to nominate candidates in addition to those put forward by the Nomination Committee; and
- (iii) to separate the balloting from the annual meeting.

The petition to amend the Unit 191 By-Laws was emailed to the unit membership in November and published in the December issue of the Bright Leaf Alert Newsletter.

No request to read the amendments, and no questions.

By-Laws revision passed unanimously.

#### 8. Hall of Fame

In 2014, Unit 191 established a Unit 191 Hall of Fame to recognize bridge players in our unit who have made major contributions in their service to Unit 191, or in promotion of the game of bridge, or in their expertise at the bridge table. - ❖ Chris Moll and Wayne Stuart were second world-wide in the World Wide Bridge Contest on June 7th with a 75.05% game. First place was taken by a pair from Greece with an 81.42% game. They will receive subsidized travel to the

2020 World Bridge Games, tentatively set to be held in Istanbul.

- ❖ Rose Meltzer won the Keohane North American Swiss Teams at the 92<sup>nd</sup> Fall North American Bridge Championships in San Francisco last Sunday. I heard it was a dramatic, close finish. Her team was leading going into the last round. They lost in that round but saved a narrow overall win. Rose has won at least three major NABC events and two open World Team championships, probably the best record by a woman in open competition history.
- ❖ Jacek Pszczola, on a team captained by Josef Blass, both of Unit 191, won the Soloway Knockout Teams two weeks ago at the Fall North American Bridge Championships. Pszczola, better known as *Pepsi*, is a bridge pro and travels so much he is seldom seen locally. Josef, however, plays in our clubs and tournaments from time to time.
