BRIDGE ETIQUETTE and PROTOCOL

TABLE MANNERS

- 1. Cards should not be taken out of the board before all players are at the table.
- 2. Before you look at your cards count your hand and ensure you have exactly thirteen cards.
- 3. **DO** greet your opponents at the table and treat them with respect and courtesy.
- 4. **DO NOT** indulge in post-mortems with your partner directly after a hand is finished. (Save it for after the game.) Not only could a post-mortem undermine partnership confidence, but it may communicate information to players who have not played the hand at other tables.
- 5. **DO NOT** criticize partner. (Keep it to yourself until after the game. You will have cooled down by then.) And you may also have figured out that you share some of the blame.
- 6. **DO** compliment your opponents for fine bidding or play. (Especially beginners)
- 7. **DO NOT** gloat! (It is ugly) Be modest.
- 8. **DO** say 'Director Please" in a pleasant tone. Keep your hand up so that the Director can quickly determine who called.
- 9. **DO** support your partner at all times. She/he is the only player in the room who is on your side!

THE AUCTION

- 1. Bidding boxes are designed to reduce the possibility of information being communicated between partners by voice intonation or other mannerisms such as eye contact. When using a bidding box, decide what your bid is going to be before reaching for or touching cards in the bidding box. An extreme example of this impropriety is when you touch a 2H card and then pull out a pass card.
- 2. **DO NOT** ask for information from your opponents unless it is your turn to bid.
- 3. **DO NOT** ask for information from your opponents unless you are intending to bid. Asking for explanation without bidding could in certain circumstances be construed as passing unauthorized information to one's partner. If one doesn't intend to bid, questions of the opponents, should be made after the auction is concluded.

PLAY OF THE HAND

- 1. **DO** say "Thank you" to your partner when he/she puts the Dummy on the table. (Even though you are thinking to yourself 'where the heck is the hand my partner was bidding?)
- 2. DO, when you are on opening lead, lead first and then write the contract on your score sheet. When you are on opening lead, detach a card from

your hand and lay it face down on the table. This prevents irregularities....such as leading when it is not your turn to do so and allows questions about the auction and any alerts to be answered. All players, except dummy, may now request a review of the auction and an explanation of any alerted calls. You, as the opening leader, may ask for any review of the bidding before you make your first lead. Other players may also ask for a review of the auction at their first opportunity to play.

- 3. DO NOT snap your cards down on the table.
- 4. DO NOT detach a card from the hand before it is your turn to play. Do not pull up a card, push it back into your hand, and then pull up another card. Nor should you detach a card and then replace it to play another card. Also do not detach your card before it is your turn to play, and never rearrange your hand when you are out of a suit. All of these maneuvers provide additional valuable information to the declarer.
- 5. You have the right to inspect the cards that have been played on the current trick as long as YOUR card remains face up. Once all cards have been turned over (face down) no one can ask to see the cards that were played.
- 6. At the end of a hand ensure that you do not mix up your cards until the result is agreed with the opponents.
- 7. Do not look at your opponent's or partner's cards after the hand has been played without their permission.

BIDDING EXPLANATION FROM BBO

Diane Bastian told a story about online bridge play last week and I thought it was useful information to share with our unit members. This bidding sequence happened when she was playing online and is an email her partner sent to the BBO and the response she received in reply.

"I am not writing to have any score changed, but just wanted it to be on record. Today in the Speedball game, our RHO opponent opened 3 clubs with:

S-962

H - 63

D-962

C-AKQ53

It's of course our hand and I double for takeout.

S-AK8

H-AJ108

D-Q843

C-102

His partner West passes.

My partner holds:

S-QJ4

H -Q42

D-K107

C-J874

She bids 3 Spades—All pass.

We are set of course—bad contract, and I know this will be considered a psych—which is allowed, etc. But I find that players are bidding more and more outrageously with no consequences. BBO has a huge audience and I personally love it and play a

lot. But for we players who pretty much follow basic bridge rules— this is sometimes hard to swallow.

Nothing to be done - our bidding error—but just had to get it off my chest. Thanks for 'listening' and I will continue to play and love every minute."

Reply from BBO:

"I am not sure that the bid would be considered psych since the player had 5 clubs and was between 5 and 11 points and vulnerable. Using the rule of 2/3/4 the player has an 8 losing trick count hand. When subtracted from 13, that results in 5. For non-vul vs. vul, 4 tricks are added making it 9. So the rule says to open it at the 3 level. https://www.larryco.com/bridge-articles/rule-of-234

Everyone is bidding more aggressively these days. To reduce this aggressive bidding, players are going to need to penalty double more often.

I played today and my LHO made a weak overcall after my partner and I had both bid. It came around to me and I doubled and my partner passed. We ended up with 800 points and probably weren't even going to bid a game.

It is sometimes hard to make a penalty double because it is assumed to be for takeout. But it is the best way to score in some sequences. Either that or just pass and take a small positive score, The normal thinking is to just try to go positive when there is a preempt on the table.

Unit 191 Mentor/Mentee program

The game was preceded by a lesson from **Michael Lavine** on second hand play. The Unit held a Tier I game on Tuesday, March 25. There were 9 tables. The winners were **Felicity Klintworth and Diana Spock,** North-South, **and Mike Sauter and Bev Craig,** East-West. The game was preceded by a lesson from **Henry Meguid** on opening bids. **Bill Ingram** wrote comments on several hands from the game.

Tier I games are held the fourth Tuesday of each month at 1:00 PM, preceded by a half-hour lesson from Henry Meguid starting at 12:15. Tier II games are held the second Tuesday of each month at 10:00 AM, preceded by a half-hour lesson beginning at 9:15. The fee is \$12 per person, except that the Unit will subsidize \$5 of the fee for each mentor who is playing with a Unit mentee. That makes the fee \$19 per pair if the mentee is from the Unit. We encourage mentees to pay their mentors' fees.

If you or your partner are unable to attend a particular M/M game, please let us know in advance so we can find someone to take your place — either a mentor or mentee who would not otherwise have a partner.
