Annual Meeting December 8, 2002 Sheraton Hotel Chapel Hill

President Connie McManus called the meeting to order with a record crowd present of 170 bridge players, including 15 guests who are non-Unit 191 members.

Treasurer's report presented by Anne Hennessey demonstrated an increase in revenue from \$7821.93 December 2001, to \$11,344.70 (full report on file). The various means through which funds were raised were cited along with how the Unit was financing several projects to improve communications and to increase the bridge playing capabilities among its members.

Paul Schwenke who noted there had been a net increase in membership of 5 with a current membership of 398 presented the report (full report on file). He also stated that our Unit was excellent in recruiting new members in comparison to other units but we continue not to do well in retaining new members after the first year. He introduced the new booklet "The Exciting New World of Bridge" and stated they along with the listing of Unit games and contacts were being placed in prominent areas in the community. The upcoming Land Cruise was promoted.

Bob Crawford presented the election results: The three incumbents, Philip Erlendbach, Bob Boggs, Carol McCaskill were reelected along with Diane Bastian. He also described the current educational program, which the Unit is sponsoring at the Chapel Hill High School noting that it would be ideal to offer similar programs at other schools in the area.

Connie McManus as outgoing president thanked various members who had contributed to the success of the Unit. Harrison Brooke thanked Connie for her dedication and leadership.

Meeting adjourned.



Carolina Inn costs continue to escalate. Including director and other fees of about \$2.00/person it would cost about \$33/person, less Unit subsidy of ?, to run this event at the Carolina Inn this year.

Switching to the Sheraton we will save us about \$4-5/person this year. Assume the Sheraton is to some extent "buying their way in", and cost will go up in a year or two, but in the interim we save a little \$\$\$.

Carolina Inn can only accommodate up to the 170 we had last year.

Only negative is that the Sheraton doesn't have any card tables so we either will have to scrounge a lot more or rent some. Given that we may be putting on three events a year if we do a NLM tournament maybe we should rethink the Unit buying some e.g. 20 this year. One problem in the past was ware to store them. Would think that 4 of us could store 5 each.
