## **Minutes of AGM 19<sup>th</sup> May 2016**

### **1. Apologies**

### **2. Minutes of last AGM & Matters arising.**

### **3. Change to the constitution**

Chairman (Marilyn Newbould) explained that the date timeframe for the AGM in the bridge club constitution (6 weeks from the end of the financial year) was difficult to achieve because of team and 2 spring SIMS events. The committee would therefore like to change the timeframe to 8 weeks to provide greater flexibility.

Alan Grunwald expressed concern that no clear reason had been given as to why the change should be made to 8 weeks rather than some other period. The secretary (Gaye Kyle) explained that in order to meet the time frame last year the AGM was held on a SIMS night. SIMS events have non-members turning up resulting in a larger than normal turnout necessitating a prompt start which is not always achievable after an AGM. Keith Robbins quickly explained that if this predicament was not settled the AGM would be unconstitutional. Kate Gould proposed the motion to change the constitution which was seconded by Keith Sadler. The motion was clearly carried by a vote of hands by the members present.
